STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and for its *Status Report* states as follows:

1. On November 23, 2011, the Staff requested the cancellation of Velocity The Greatest Phone Company Ever, Inc's (Velocity) certificates of service authority and associated tariffs to provide intrastate interexchange and basic local exchange telecommunication services in the state of Missouri.

2. After several filings in the case, the Commission issued its *Order Directing Filing Of Status Report (Order)* on April 16, 2012, directing the Staff to file status reports on the first business day of each month.

3. Since the Staff's last status report, the Staff has sent Velocity deficiency notices regarding its 2009 and 2010 basic local exchange annual report filings, and its 2009 interexchange annual report filing.

4. The Company has shown some diligence in clearing the deficiencies that led to these filings and the Staff is confident that the Company will continue to do so.

5. The Commission's *Order* allows the Company until August 1, 2012, to resolve the deficiencies. Once Velocity clears all the deficiencies, the Staff will move that these matters be closed without further action.

WHEREFORE, the Staff submits this *Status Report*.
