## STATUS UPDATE

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and for its status update in this matter respectfully states:

- 1. On July 11, 2000, the Staff filed a motion recommending that the Commission cancel Fiberline Networks Communications, L.P.'s ("Fiberline") certificate of service authority to provide intrastate interexchange telecommunications services, granted on August 7, 1990 in Case No. TA-90-135, and accompanying tariff. Staff gave notice of its motion via United States Mail to Mr. Scott Nauert, President of Fiberline, and to Fiberlines's attorneys who filed the application. Subsequently, the United States Postal Service ("USPS") returned the letter addressed to Mr. Nauert as undeliverable and marked "Attempted, Not Known."
- 2. In accordance with the procedure directed by the Commission in similar cases, Staff gave notice, via certified United States Mail return receipt requested, to Mr. Nauert and to Fiberline's attorneys of Staff's motion recommending the Commission cancel Fiberline's certificate of service authority and tariff. Subsequently, the USPS returned the letter addressed to Mr. Nauert as undeliverable and marked "Attempted, Not Known." The USPS returned the receipts showing delivery of the letters addressed to Fiberline's attorneys.



3. On July 13, 2000, Staff received a letter indicating that Robert L. Hawkins, III no longer practices law in the State of Missouri or conducts any legal business and should be removed from the service list.
