ORDER SETTING PROCEDURAL SCHEDULE

On March 19, 2007, Socket Telecom, LLC, filed a complaint against CenturyTel of Missouri, LLC, d/b/a CenturyTel and Spectra Communications Group, LLC, d/b/a CenturyTel, alleging that CenturyTel is violating their interconnection agreement. CenturyTel denies the allegations.

On April 17, 2007, per Commission order, the parties filed a Joint Motion to Establish Procedural Schedule. Commission Rule 4 CSR 240-2.080(15) allows parties ten days to respond to pleadings. But because no parties oppose the motion, the Commission will dispense with the ten-day period for responses, and the Commission will consider the proposed schedule unopposed. The Commission finds the proposed procedural schedule reasonable, and will adopt it.

IT IS ORDERED THAT:

1. The parties' Joint Motion to Establish Proposed Procedural Schedule is granted, and the proposed schedule is adopted.
