APPLICATION OF AMEREN CORPORATION AND UNION ELECTRIC COMPANY TO INTERVENE

COME NOW Ameren Corporation and Union Electric Company d/b/a AmerenUE ("AmerenUE") (collectively referred to as "Ameren"), a Missouri corporation, and pursuant to 4 CSR 240-2.075, hereby applies to intervene in the above-captioned matter and to become parties herein. In support thereof, Ameren states as follows:

- 1. AmerenUE is a corporation duly organized and existing under the laws of the State of Missouri with its principal office located at 1901 Chouteau Avenue, St. Louis, Missouri 63103, and is an electrical corporation and public utility as defined in Section 386.020, RSMo. AmerenUE is engaged in providing electric, gas and steam heating services in portions of Missouri as a public utility under the jurisdiction of the Commission. AmerenUE is also engaged in providing electric and gas service in portions of Illinois. Ameren Corporation is a public utility holding company registered with the Securities and Exchange Commission under 15 U.S.C. §79 et seq. Ameren Corporation owns two public utilities, AmerenUE and Central Illinois Public Service Company which does business as AmerenCIPS ("AmerenCIPS").
- 2. In this proposed rulemaking, the Commission is proposing to adopt rules governing affiliate transactions among electric utilities and their subsidiaries.
- 3. As an electric utility and owner of an electric utility subject to Commission jurisdiction, Ameren seeks intervention because any affiliate transaction rules adopted by the

Commission will directly affect the way in which AmerenUE conducts its business, and Ameren's interest is different from that of the general public and cannot be represented adequately by any other party to this proceeding.

4. Ameren opposes the adoption of the rules proposed governing affiliate transactions as set forth in its Comments submitted to this Commission. Ameren has proposed alternative rules that accomplish the goals identified and that are less costly and that increase consumer welfare.

WHEREFORE, for the foregoing reasons, Ameren Corporation and Union Electric Company respectfully request that the Commission grant this Application to Intervene and allow them to become parties to this proceeding with all rights attendant thereto.
