This notice serves to inform the parties that this case has been reassigned to Regulatory Law Judge Nancy Dippell. Having reviewed the file, it appears that this case is ready for Commission action on the motion to dismiss for lack of jurisdiction. However, the complainant, DeLana Smith-Sattarin, indicated in her response filed on June 21, 2016, that she had not received a copy of the prehearing transcript.

Thus, in order to give the complainant time to review the prehearing transcript, the Commission will allow time for one additional response from Ms. Smith-Sattarin, with regard to the Commission's jurisdiction to provide her some relief. If the complainant should require additional time, she should file a further request.

1. DeLana Smith-Sattarin may submit a further response, as described in the body of this Notice and Order, no later than September 1, 2016.
2. The Commission's Data Center shall mail a copy of this notice to the Complainant.
3. This order shall be effective when issued.
