RESPONSE TO COMPLAINT

Arizona Telephony Brokers, L.L.C. (hereinafter "Respondent"), by its attorneys, hereby respectfully requests that the Missouri Public Service Commission (the "Commission") dismisses the Complaint dated January 29, 2004 in the above-referenced Case. The Respondent declines mediation.

Respondent was served with Notice of Complaint on February 4, 2004 stating that 2002 Annual Report and assessment was not filed on or before April 15, 2003.

The Complaint was served on Respondent by its registered agent on February 12, 2004.

Notice Regarding Mediation was served on Respondent by its registered agent on February 24, 2004.

Upon receipt of the Commission's Complaint, Arizona Telephony Brokers, LLC took immediate steps and responded to the Commission's request by submitting the Annual Report to the Missouri Public Service Commission. Respondent has been notified that the filing of the annual report does not dismiss litigation proceedings and that the Respondent may still be liable under Commission rules and regulations.

Arizona Telephony Brokers, L.L.C. submitted a completed 2002 Annual Report form to the Commission's Data Center. The document was stamped "Received, February 17, 2004, Records, Public Service Commission." Staff has reviewed that submission and has determined that it has been completed as required. The document has been placed in the Electronic Filing and Information System and assigned the tracking number BMAR-2004-0082.

Furthermore, subsequent to the initial deadline for filing the 2002 Annual Report, Respondent entered into a contract with Telecom Compliance Services, Inc., a nationally known regulatory compliance firm to assist Respondent to comply with the reporting requirements of the regulatory authorities throughout the United States, including the Missouri Secretary of State and the Missouri Public Service Commission.

Respondent earnestly apologizes to the Commission, and would like to assure the Commission that its future filings will be timely and accurate. Respondent has taken steps, and will take any further necessary steps, to insure that it remains in compliance with Commission rules and regulations.

WHEREFORE, Arizona Telephony Brokers, L.L.C. respectfully requests to maintain their certificate of service authority in the state of Missouri and that the Complaint be dismissed for the reasons set forth herein.
