On June 30, 2011, Missouri-American Water Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for water and sewer service provided to customers in the Missouri service area of the Company. The proposed tariffs bear a requested effective date of July 30, 2011. The proposed water service tariffs are designed to produce an annual increase of approximately 17.98% in the Company's revenues.

- 4. The City of Warrensburg seeks to intervene in this rate case proceeding but at this time takes no position on any of the issues underlying the proposed rate increase.
  - 5. The City of Warrensburg's interests are different from those of the general public.
