- JUDGE WOODRUFF: Let's go on the record.
- 3 This is the prehearing conference in the
- 4 matter of Missouri Public Service's Purchased Gas Adjustment
- 5 Factors to be Audited in it's 1998-1999 Actual Cost
- 6 Adjustment, Case No. GR-99-435.
- 7 And let's begin by taking entries of
- 8 appearance, and beginning with UtiliCorp.
- 9 MR. COOPER: Dean L. Cooper from the law firm
- 10 of Brydon, Swearengen & England, P.O. Box 456, Jefferson
- 11 City, Missouri 65102, appearing on behalf of UtiliCorp
- 12 United, Inc., doing business as Missouri Public Service.
- 13 JUDGE WOODRUFF: And for Staff?
- MR. FREY: Representing the Staff of the
- 15 Missouri Public Service Commission, Dennis L. Frey, P.O.
- 16 Box 360, Jefferson City, Missouri 65102.
- JUDGE WOODRUFF: And for Public Counsel?
- 18 MR. MICHEEL: Douglas E. Micheel appearing on
- 19 behalf of the Office of the Public Counsel and the Public,
- 20 P.O. Box 7800, Jeff City, Mo. 65102-7800.
- JUDGE WOODRUFF: Thank you. And Mr. Frey, I
- 22 believe you had some matters you wanted to bring up?
- 23 MR. FREY: Yes, sir. Thank you, your Honor.
- 24 The parties -- speaking on behalf of the parties, I believe
- 25 that our main concern at this point is to ensure that this

- 1 docket is held open, this case is held open until the
- 2 resolution of the related case GO-2001-249, and that it
- 3 would be premature at this point to develop a procedural
- 4 schedule given that we don't know when that case will be
- 5 resolved.
- 6 JUDGE WOODRUFF: Can you explain for me what
- 7 that other case is? I think it's mentioned in here, but
- 8 refresh my memory.
- 9 MR. FREY: I don't know the details of that
- 10 case, but as I understand it there are some allegations
- 11 of -- okay. Would it be all right if Phil Lock spoke to
- 12 that at this point? He's our representative from the Staff.
- JUDGE WOODRUFF: Okay.
- 14 MR. LOCK: I'm Phil Lock. I can just briefly
- 15 give you the investigation docket deals with an alleged
- 16 allegation by the employees of UtiliCorp of some fraud going
- 17 on, profit taking going on in the company, and that we're --
- 18 currently right now we're going through the discovery phase
- 19 of that investigation to determine whether or not those
- 20 allegations were true or not, and they -- right now it's
- 21 basically an open docket.
- There hasn't been any dates set up for that
- 23 investigation docket as far as a hearing or anything else
- 24 until Staff has the opportunity to make -- to look at the
- 25 discovery and make a determination whether or not those

- 1 allegations are true or false.
- 2 So until we get some specific dates on that
- 3 investigation docket, we're not -- I'd feel like it's not
- 4 appropriate at this point to set up any kind of procedural
- 5 schedule in this case.
- 6 JUDGE WOODRUFF: Now. Staff had indicated in
- 7 its recommendations that there was partial agreement on some
- 8 of the issues. Is that correct?
- 9 MR. COOPER: I believe that's correct, your
- 10 Honor. As to the issues that have been raised thus far in
- 11 this proceeding, I think there has been agreement on several
- 12 issues.
- 13 I think there only remains one issue, which is
- 14 not necessarily an issue that will be resolved by any sort
- 15 of dollar adjustment but instead has to do with some
- 16 procedures that the company will follow. That's the only
- 17 issue that's currently in the docket that remains
- 18 outstanding.
- 19 I would like to say a couple things. First,
- 20 in regard to what Mr. Frey said earlier, I don't -- he said
- 21 he was speaking on behalf of the parties. I don't know that
- 22 I join in his request that this docket be kept open
- 23 indefinitely.
- I will say that as far as his request goes
- 25 towards asking the Commission for its guidance as to whether

- 1 we should indeed move forward with the procedural schedule
- 2 or not, I do join in that portion of his request.
- JUDGE WOODRUFF: Do you agree that the only
- 4 issue remaining is the one that's going to be dealt with in
- 5 this other case? Is everything else resolved?
- 6 MR. COOPER: No. I think that if we set aside
- 7 the case that Mr. Lock was describing, I think there is a
- 8 small issue still remaining in this docket that can be
- 9 resolved in this docket exclusive of the case that Mr. Lock
- 10 has described.
- 11 JUDGE WOODRUFF: What issue would that be?
- MR. COOPER: Well, I'll have to go back
- 13 through and trace the recommendations. Do you remember,
- 14 Phil?
- MR. LOCK: It dealt with pricing of
- 16 imbalances, its accounting methodology of pricing
- 17 imbalances, and so we're -- the Company and Staff are
- 18 currently trying to resolve that issue.
- JUDGE WOODRUFF: So there are still
- 20 negotiations going on with that?
- 21 MR. LOCK: There are. And currently, I might
- 22 add, too, that there's a current ACA case, too, which I
- 23 suspect we're going to a similar issue in that respect.
- 24 We'll be addressing it then. So there will be another
- 25 opportunity to address that issue in the current ACA case

- 1 that's going on with MoPub.
- JUDGE WOODRUFF: Okay. Well, I don't think
- 3 I'm going to be able to resolve it from the Bench here
- 4 today. Mr. Frey, if you want to go ahead and file a motion
- 5 explaining your position on it, and, of course, UtiliCorp
- 6 will have an opportunity to reply to that, and I'll present
- 7 it to the Commission as to how they want to proceed with it.
- 8 If it's possible to explain what the issues
- 9 are, I think you already have, and explain what issues have
- 10 been agreed upon, and if there's no need for a procedural
- 11 schedule at this time, that's fine.
- 12 Is there any reason that we need to do this
- 13 partially? Is there any urgency to resolving the issues
- 14 that have been agreed upon? And you can explain that in
- 15 your motion if you like or explain it to me today if you
- 16 want.
- 17 MR. COOPER: I'll wait and see Mr. Frey's
- 18 motion, I guess.
- MR. FREY: Me, too.
- 20 JUDGE WOODRUFF: Okay. Well, the deadline
- 21 that was ordered in the earlier order was January 23rd for
- 22 preparing a procedural schedule. If you give me a motion
- 23 before then, I'd appreciate it, Mr. Frey.
- MR. FREY: Thank you, your Honor.
- JUDGE WOODRUFF: Any other matters anyone
