APPLICATION TO INTERVENE OF IBEW LOCAL 412

COMES NOW International Brotherhood of Electrical Workers, Local 412 (“Local 412” or “Union”), by and through undersigned counsel, and hereby petitions the Missouri Public Service Commission (“Commission”) to grant this Application to Intervene in the above-referenced proceedings, pursuant to 4 CSR 240-2.075. In support of this Application, the Union states:

1. International Brotherhood of Electrical Workers, Local 412, is an unincorporated association and labor organization representing approximately 430 employees of Evergy working in the States of Kansas and Missouri. Local 412 represents certain Evergy employees for the purposes of engaging in collective bargaining. Local 412’s Business Manager is Shawn Edwards, and the Union’s business address is 1760 Universal Avenue, Kansas City, Missouri 64120. The Local’s email address is business.manager@ibew412.org, and the phone number is (816) 231-4530.

2. As noted herein, Local 412 represents approximately 430 employees at Evergy, working in the States of Kansas and Missouri. The work performed by these employees is directly related to the processes of electrical generation for customers in Kansas and Missouri, and capital expenditures related to electrical generation and production will have a direct impact on the employees represented by Local 412, and a direct impact on the Union itself.

3. The public interest would be served by granting this Application, as the Union and its members have a clear and significant interest in the outcome of this proceeding, as the Union and its members may be adversely affected by the Commission's actions and orders. Moreover, there is no other party to this proceeding that will adequately represent the interests of the Union and its members. Finally, this proceeding will not be impaired should the Union's Application be sustained.
