| 3 | JUDGE HOPKINS: Ladies and Gentlemen: If I |
| 4 | could have your attention we will begin this hearing. And |
| 5 | I will ask the court reporter to go on the record, please. |
| 6 | If anybody would like to testify, that's what we came here |
| 7 | for. And we'll be glad to have somebody testify. If you |
| 8 | would like to testify we would like you to testify and we |
| 9 | can have you sign up here. You can't speak from the floor |
| 10 | unless you are sworn in, come forward and testify. |
| 11 | We are in the City of Wentzville, St. Charles |
| 12 | County, August 21st, 2000 in Wentzville City Hall. My |
| 13 | name is Bill Hopkins. I'm the appointed Senior Regulatory |
| 14 | Law Judge for the Missouri Public Service Commission. And |
| 15 | I will be the Presiding Officer this evening in the matter |
| 16 | of Union Electric, d/b/a AmerenUE for Authority to File |
| 17 | Tarriffs Increasing Rates for Gas Service Provided to |
| 18 | Customers in the Missouri in the Company's Missouri |
| 19 | Service area. Case No. GR-2000-512. |
| 20 | This case began on February 18, 2000 when |
| 21 | Union Electric Company d/b/a AmerenUE submitted to the |
| 22 | Missouri Public Service Commission Tariffs requesting |
| 23 | increased rates for natural gas service provided to |

24 customers in the Missouri service area of the Company.

25

The proposed tariffs bear a requested effective date of

```
1 April 2, 2000. The proposed tariffs are designed to
```

- 2 produce an annual increase of approximately 14 percent in
- 3 the Company's natural gas revenues. That is about \$12
- 4 million annually.
- 5 First, let me thank the City of Wentzville
- 6 for the use of this facility. And I will note that the
- 7 views expressed here are not necessarily those of the City
- 8 of Wentzville. In addition, we would like to thank the
- 9 staff of the Public Service Commission and the Public
- 10 Counsel and the people from AmerenUE for showing up here
- 11 tonight and their assistance.
- 12 Let me introduce to you the Commissioners who
- 13 are present here this evening to hear your testimony, if
- 14 we could get somebody to testify. On my left is Chair
- 15 Sheila Lumpe. She is the Presiding Commissioner of the
- 16 Missouri Public Service Commission. Here on my right is
- 17 Commissioner Connie Murray. She's also on the Missouri
- 18 Public Service Commission.
- 19 And if I could, please, have the Attorneys
- 20 enter their appearance for the record, and generally
- 21 introduce themselves, if you haven't already, to the
- 22 public. Start with you. Have you filled out these?
- MR. SNODGRASS: No, we haven't, Judge.
- JUDGE HOPKINS: Go ahead, Mr. Snodgrass, and
- 25 we'll let you all fill these out, too. Thank you.

1 MR. SNODGRASS: I guess I'll start with the
```

- 2 introduction. Good evening, everybody. My name is Cliff
- 3 Snodgrass. I'm Senior Counsel representing the interest
- 4 of the staff of the Missouri Publice Service Commission
- 5 this evening. Thank you.
- JUDGE HOPKINS: Mr. Dandino?
- 7 MR. DANDINO: My name is Mike Dandino. I'm
- 8 with the office of the Public Counsel. We represent the
- 9 public, the consumers in this case. And just as a
- 10 sideline, I would urge anyone here, if you're interested
- 11 enough to come to this meeting, please come forward and
- 12 testify. It helps us do our job representing you.
- 13 MR. EVANS: My name is Ron Evans. I'm the
- 14 Attorney representing AmerenUE. This is Tom Byrne. He's
- 15 also an Attorney representing AmerenUE. I would also
- 16 mention at this time there are several representatives
- 17 form the Company here tonight. Just mentioning a few,
- 18 this is Ron Zeller, he's the Vice President of our
- 19 Customer Service Department; Craig Nelson, he's the Vice
- 20 President of our Corporate Planning Department, whose
- 21 responsibility it is for rate matters. This is Bob Smith
- 22 our Wentzville District Manager. And Rich Kovac in the
- 23 back by the window is the Manager of our Rate Engineering
- 24 Department.
- 25 JUDGE HOPKINS: All right. Thank you very

1 much. Let me just briefly explain to you the agency. The

- 2 Missouri Public Service Commission is the State agency
- 3 which regulates the investors on the utility companies in
- 4 Missouri to ensure that the rates are just and reasonable;
- 5 that the quality of service is satisfactory; and that
- 6 safety practices are employed in their operations, while
- 7 at the time ensuring the utility companies a reasonable
- 8 rate of return to their shareholders.
- 9 The Missouri Public Service Commission is made
- 10 up of five Commissioners who are employed by the Governor
- 11 and confirmed by the Senate to hear and decide cases
- 12 regarding the public utility issues regulated as indicated
- 13 earlier.
- 14 The current Commissioners are Chair Sheila
- 15 Lumpe, who I've already introduced; Vice Chair Dianne
- 16 Drainer; Connie Murray, who I've already introduced;
- 17 Robert Schemenauer; and Kelvin Simmons. The
- 18 Commissioners, including those who are not currently
- 19 present, will have the opportunity to read all the
- 20 witnesses' testimony and remarks.
- 21 The Missouri Public Service Commission
- 22 employs a staff of engineers, accountants, attorneys,
- 23 financial analysis, and other specialists in the field of
- 24 utility regulation and relies upon their expertise, along
- 25 with other expert testimony and consumer testimony. These

1 people here that introduced themselves earlier, I think

- 2 the only one we had from the staff that interviewed
- 3 himself was Mr. Snodgrass, but you may have met some of
- 4 the staff during the earlier presentation, they represent
- 5 the PSC staff and the office of General Counsel. You also
- 6 met the Attorney for the Office of General Counsel. And
- 7 Mr. Dandino is from that office -- Public Counsel. I'm
- 8 sorry, Mr. Snodgrass is from General Counsel; Mr. Dandino
- 9 is Public Counsel. Thank you. And the Public Counsel is
- 10 separate from the PSC, and they represent the public's
- 11 interests specifically before the Public Service
- 12 Commission.
- 13 The purpose of this hearing, we all came here
- 14 tonight to listen to the views of the rate payers, the
- 15 citizens of St. Charles County and Wentzville,
- 16 specifically. To take evidence by way of your statement
- 17 or testimony or any written statements or documents that
- 18 you may wish to provide to the Missouri PSC regarding
- 19 AmerenUE's application for a rate increase.
- 20 We will take your comments from this evening,
- 21 along with the other public hearings and follow-up with a
- 22 review and a report which will be issued, including any
- 23 issues which you may raise with us tonight relating to
- 24 this proposed rate increase.
- Now, I'm going to ask the Commissioners, if

1 any one of them would like to have an opening statement.

- 2 Chair Lumpe?
- 3 OPENING STATEMENT
- 4 BY CHAIR LUMPE:
- 5 Very briefly, we do appreciate your coming
- 6 out. We are here to hear your testimony and to hear your
- 7 thoughts. Also, you see the other representatives that
- 8 are here, and it gives you an opportunity to speak to
- 9 them. If you have individual issues or problems you have
- 10 been wishing to speak to them about, they're here also. I
- 11 think that one of the reasons we started the prehearing
- 12 was because frequently people came and they had more
- 13 questions than comments.
- 14 And so we thought it would be helpful to let
- 15 people be able to ask their questions and perhaps get
- 16 those answered. And then they could make their comments
- 17 based on that information that they had been given. And
- 18 we found that that has worked very well. So we appreciate
- 19 those of you who came early who maybe had questions and of
- 20 course afterwards, when we conclude this, if you have
- 21 further questions I know our staff stays around and so
- does the Company, and would be happy to answer other
- 23 questions if you might have any for them then. So we do
- 24 appreciate your taking the time to come out. And we do
- 25 hope you'll share your comments with us. Thank you.

JUDGE HOPKINS: Thank you very much, Chair

- 2 Lumpe. Commissioner Murray?
- 3 COMMISSIONER MURRAY: I don't really have
- 4 much to add to that. I do hope that you got the
- 5 information that you were seeking by coming early and
- 6 having time to get a few of your questions answered. And
- 7 if you do have an opinion that you would like to share
- 8 with us we are certainly here to do that tonight. And we
- 9 would appreciate your doing so. Thank you.
- 10 JUDGE HOPKINS: General Counsel, do you wish
- 11 to make an opening statement?
- MR. SNODGRASS: Not at this time, Judge, I
- don't believe so, but we're here to answer any questions
- 14 anybody might have for us.
- JUDGE HOPKINS: Mr. Dandino, for Public
- 16 Counsel?
- 17 MR. DANDINO: Yes, Your Honor. Just once
- 18 again, this Commission is here to see what the rate payers
- 19 think about this proposal. If you think it's reasonable,
- 20 unreasonable, fair, or unfair, what does it mean to you?
- 21 What does it mean to you in paying your gas bills this
- 22 winter? That's what they're here to hear. If no one
- 23 comes forward to say, just giving them your opinion about
- 24 this proposal, you know, they're going to have a blank
- 25 record to show the other Commissioner. They'll say:

1 Well, nobody made a comment. That's why I think it's very

- 2 important that you come up here, even if you come up here
- 3 and say: I don't like it. Is important for them to hear
- 4 from you because that is one element in this. They can
- 5 look at the accountant's records. They can look at the
- 6 engineer records. They can look at what all the lawyers'
- 7 arguments they want, but this Commission also has a record
- 8 of looking at what the rate payers say about it,
- 9 especially if they say whether it's fair, reasonable, and
- 10 affordable rates. Thank you.
- JUDGE HOPKINS: Thank you. AmerenUE, any
- 12 opening statements.
- MR. EVANS: Only that we appreciate the
- 14 opportunity to be here tonight. And we're here to hear
- 15 your concerns and we brought a number of people to answer
- 16 any questions that you might have.
- 17 JUDGE HOPKINS: Thank you, sir. Now, is
- 18 there anyone here who would like to testify?
- 19 ****
- 20 CLEVELANDA HARWOOD,
- 21 Of lawful age, being first duly sworn to tell the truth,
- 22 the whole truth, and nothing but the truth, deposes and
- 23 says on behalf of the Publice Serice Commission, as
- 24 follows:
- 25 TESTIMONY

1 JUDGE HOPKINS: Would you please state and

- 2 spell your name for the court reporter?
- 3 THE WITNESS: Clevelanda Harwood,
- 4 C-l-e-v-e-l-a-n-d-a, H-a-r-w-o-o-d.
- 5 JUDGE HOPKINS: Thank you, ma'am. You may be
- 6 seated. Just go right ahead and tell us whatever you want
- 7 to.
- 8 THE WITNESS: Well, I personally don't think
- 9 that this rate increase is very fair. There are a lot of
- 10 citizens in the City of Wentzville and the surrounding
- 11 area that are on fixed incomes. My mother was one of
- 12 them. This card came addressed to my mother who has been
- 13 deceased for six weeks. Apparently AmerenUE also has
- 14 problems getting their records straight because this card
- 15 came to a decreased person.
- 16 At the time we transferred her bill to my
- 17 husband and I, because we also own the property, we
- 18 received a final bill that was estimated. I called and
- 19 questioned that and was told: I have no idea why the bill
- 20 was estimated. So I find it very difficult to feel that
- 21 this rate increase is correct. I mean, they're not
- 22 getting their records straight. And how do we know, if
- 23 they can't get simple accounting records straight, how do
- 24 we really know that this rate is justified? I'm not on a
- 25 fixed income, but, like I said, my mother was. And I know

1 there are a lot of people in my neighborhood in this City
```

- 2 that are. An increase of 14 percent when you're living on
- 3 \$600 or \$700 a month is a lot of money.
- 4 JUDGE HOPKINS: Okay. Thank you very much.
- 5 I'm going to see if any of the Commissioners would like to
- 6 ask you some questions. Chair Lumpe?
- 7 CHAIR LUMPE: No. I have no questions. I
- 8 just appreciate you're coming to testify.
- 9 THE WITNESS: Thank you.
- 10 JUDGE HOPKINS: Commissioner Murray?
- 11 COMMISSIONER MURRAY: First of all, I'm sorry
- 12 for the loss of your mother. Secondly, I would like to
- 13 ask if you have spoken to anyone from the Company to try
- 14 to get some clarification about the bill?
- 15 THE WITNESS: Yes, I did. When we got her
- 16 final bill I paid it. It wasn't until we got the first
- 17 bill, the new bill under my husband's and my name was for
- 18 \$8.00 that was sent that I questioned it. And they're
- 19 like: Well, those are the readings. In the meantime, I
- 20 went back and I looked at her final bill. And on that
- 21 final bill it said: Estimated bill. And it also has the
- 22 words "final" on it. That's when I called the 800 number.
- 23 There were two different people there that evening,
- 24 customer service people, and their response was: We have
- 25 no idea why this bill was estimated. We have the actual

- 1 readings. So they did redo the bill. They did get the
- 2 bill corrected. But if this had happened to someone else,
- 3 you know, and the bill was not transferred to someone.
- 4 What if it had been you and you had gotten this bill, you
- 5 may never have realized that this bill was outlandish and
- 6 questioned it.
- 7 COMMISSIONER MURRAY: Thank you. That's all
- 8 the questions I have.
- 9 JUDGE HOPKINS: Thank you. General Counsel,
- 10 any questions?
- 11 MR. SNODGRASS: I don't believe so. Judge,
- 12 for the record, we would tell you, ma'am, that we do have
- 13 a Consumer Services Division with the staff of the Public
- 14 Service Commission for these kind of inquiries and/or
- 15 complaints. And we would encourage you to use that
- 16 avenue, ma'am.
- 17 THE WITNESS: All right.
- JUDGE HOPKINS: Public Counsel?
- MR. DANDINO: Yes, Your Honor. Ms. Harwood.
- 20 Thank you very much for coming forward testifying on
- 21 behalf of, not only our office, but I think of all the
- 22 rate payers in this area. I think your comments were very
- 23 enlightening for this Commission. I did want to also say
- 24 to you that there is an opportunity, I think the head of
- 25 AmerenUE's Customer Service Department is here tonight.

1 It would be a very good opportunity to talk directly to

- 2 the top person and try to get this thing resolved here
- 3 tonight before you leave.
- 4 THE WITNESS: Thank you.
- 5 MR. DANDINO: That's all I have. Thank you.
- 6 JUDGE HOPKINS: Thank you, sir. Anyone from
- 7 the utility?
- 8 MR. EVANS: I'm also very sore for your loss.
- 9 If we had the account address where you had the problem
- 10 that would help us determine if there still is a problem
- 11 there or a place we could get back to.
- 12 THE WITNESS: Right. You're more than
- 13 welcome to have it. That's why I brought this particular
- 14 card with me. Thank you.
- MR. SNODGRASS: Ma'am, here's our Consumer
- 16 Services Division number.
- JUDGE HOPKINS: Thank you, ma'am. We
- 18 certainly appreciate your testimony.
- 19 THE WITNESS: Thank you.
- JUDGE HOPKINS: Randy Calwell:
- 21 MR. CALWELL: I signed the wrong list. I'm
- 22 not speaking. I'm just a partial observer here.
- JUDGE HOPKINS: Mary Bradly
- 24 ****
- 25 MARY BRADLEY,

1 of lawful age, being first duly sworn to tell the truth,

- 2 the whole truth, and nothing but the truth, deposes and
- 3 says on behalf of the Public Service Commission:
- 4 TESTIMONY
- 5 JUDGE HOPKINS: Please be seated and state
- 6 and spell your name for the court reporter.
- 7 THE WITNESS: Mary, M-a-r-y, Bradley,
- 8 B-r-a-d-l-e-y.
- 9 JUDGE HOPKINS: Go right ahead.
- 10 THE WITNESS: Well, last summer I had been
- 11 getting my bills and it would say sometimes estimated on
- 12 my bills for electric and sometimes it would say actual.
- 13 I think it was in May I had gotten a bill for actual
- 14 readings. It said I should get back \$124 and something,
- 15 and so they would take it off over the next two bills. So
- 16 they did. So then in a couple, three months I got a bill
- 17 for \$286 that I owed them that was in error.
- 18 Well, I called the number. I got no
- 19 satisfaction whatsoever. They told me, they said: Well,
- 20 somebody will come out and read it. And I never got in
- 21 touch -- I mean, nobody ever got in touch with me or
- 22 responded or anything. And then I got another bill from
- 23 them for the same amount. So I finally just ended up
- 24 paying it because I couldn't get any satisfaction from
- 25 them talking over the telephone.

```
1 JUDGE HOPKINS: Did you owe that amount?
```

- THE WITNESS: I guess I did. I paid it.
- 3 They said I did. The one bill said actual and I should
- 4 get back \$127, which they did take it off my next bill.
- 5 But then I get other one that says I owe \$286 or something
- 6 like that. It was very confusing. So I told them: I
- 7 want them to read the actual each time so I know what's
- 8 going on. So from then on it says actual on it.
- 9 JUDGE HOPKINS: Thank you very much.
- 10 CHAIR LUMPE: And have you seen someone come
- 11 out and actually read it?
- 12 THE WITNESS: No.
- 13 CHAIR LUMPE: But it is saying actual on the
- 14 bill?
- THE WITNESS: Yes.
- 16 CHAIR LUMPE: And you did request you want no
- more estimated bills?
- THE WITNESS: No, I don't.
- 19 CHAIR LUMPE: Again, as Mr. Snodgrass said,
- 20 we do have a Consumer Affairs Department and an 800 number
- 21 and quite frequently they are able to help.
- THE WITNESS: I didn't know that.
- 23 CHAIR LUMPE: We can give you a card tonight
- 24 and you can be aware of it for the future. We hope there
- 25 wouldn't be a future, but thank you for coming and

- 1 testifying.
- 2 THE WITNESS: I don't either.
- JUDGE HOPKINS: Commissioner Murray?
- 4 COMMISSIONER MURRAY: I don't have any
- 5 questions. Thank you.
- JUDGE HOPKINS: Commissioner Snodgrass?
- 7 MR. SNODGRASS: Yes, ma'am, just briefly, the
- 8 staff wanted me to ask you a couple of basic questions,
- 9 perhaps they can help you resolve the situation to your
- 10 satisfaction. The first question was: Do you know,
- 11 ma'am, if you have an electronic meter at your billing
- 12 area?
- 13 THE WITNESS: For my electric I do, but I
- 14 don't know about the gas.
- MR. SNODGRASS: What period of time did this
- 16 situation arise in, do you recall?
- 17 THE WITNESS: I think it started around the
- 18 first of the year and went up through to May.
- MR. SNODGRASS: The first of 2000?
- THE WITNESS: Uh-huh.
- 21 MR. SNODGRASS: All right. I would like to
- 22 give you a card here. It's our consumer inquiry complaint
- 23 number for the Public Service Commission. And we would
- 24 encourage you to use that number when you have these kind
- 25 of problems in the future.

1 THE WITNESS: But when I called that number

- 2 they just kept saying: Well, you owe it.
- 3 MR. SNODGRASS: I don't think you understand.
- 4 This is the Public Service Commission's number to help you
- 5 resolve it. This is not the number you have been calling.
- 6 I'm sorry, maybe I didn't introduce myself properly.
- 7 That's all I have.
- 8 JUDGE HOPKINS: Public Counsel, do you have
- 9 any questions?
- 10 MR. DANDINO: Just briefly, Ms. Bradley. How
- 11 much does your gas bill usually run?
- 12 THE WITNESS: Well, right now it's running
- 13 around \$10-something a month. All I have is just a hot
- 14 water heater.
- MR. DANDINO: So in the winter months it
- 16 doesn't change that much. You have electric heat?
- 17 THE WITNESS: No. I have gas heat.
- 18 MR. DANDINO: How much is it during the
- 19 winter months?
- THE WITNESS: Oh, I would say about \$100 or
- 21 \$125.50, something like that. So this increase is going
- 22 to mean quite a bit for me, and I'm a widow.
- MR. DANDINO: Are you on a fixed income?
- THE WITNESS: Yes.
- 25 MR. DANDINO: Also, I did want to say to you

1 I think a UE Customer Service Representative is here. And

- 2 I strongly urge you tonight to talk with him because I
- 3 think that if you've got a \$286, just because they billed
- 4 it, doesn't mean you owe it.
- 5 THE WITNESS: Well, I know that but I didn't
- 6 want them to turn my lights and gas off.
- 7 MR. DANDINO: I think you have a remedy. And
- 8 if our office can be of assistance in this we would gladly
- 9 do it, but if you want to talk to AmerenUE people maybe
- 10 they can resolve it. I'll give you our card. Make sure
- 11 that you pay only what you are supposed to pay. Okay?
- 12 THE WITNESS: Okay.
- MR. DANDINO: Thank you very much.
- MR. SNODGRASS: Just for the record, Cliff
- 15 Snodgrass again. Just for clarification, if you would
- 16 like, ma'am, we would like to get your name and number.
- 17 We can investigate that for you if you would like. Would
- 18 you leave that with us before you leave?
- 19 THE WITNESS: Yes.
- 20 MR. SNODGRASS: All right. I appreciate it.
- 21 JUDGE HOPKINS: Any more questions for UE
- 22 representatives.
- 23 MR. EVANS: I would like to tell Ms. Bradley
- 24 that she can talk to our Customer Service Representatives.
- 25 They're here tonight. We'll make sure that you were

- 1 billed probably. When the bill says actual readings, it
- 2 is actual readings and verify that. And if you give us
- 3 your address we'll pull your account number. We may not
- 4 have an answer tonight, but we can verify all that and get
- 5 back to you.
- THE WITNESS: I went out to where the Company
- 7 used to be and there was nobody out there to talk to. And
- 8 I would have liked to have had somebody to talk to instead
- 9 of on the phone.
- 10 JUDGE HOPKINS: Thank you, Ms. Bradley. Now,
- 11 the next witness we have is Dennis Kramme.
- 12 ****
- DENNIS KRAMME,
- 14 of lawful age, being first duly sworn to tell the truth,
- 15 the whole truth, and nothing but the truth, deposes and
- 16 says on behalf of the Public Service Commission, as
- 17 follows:
- 18 TESTIMONY
- 19 JUDGE HOPKINS: Please state and spell your
- 20 name for the court reporter.
- 21 THE WITNESS: Dennis Kramme, K-r-a-m-m-e, and
- 22 I'm here to represent Emmaus Homes, Incorporated in Warren
- 23 County. I have to admit that I was a little confused by
- 24 the card that I got in the mail. I thought this was
- 25 regarding my electric, and somebody just said this was gas

1 we're talking about. And I missed on here the 5:30 time,

- 2 so I missed the presentation. My concern tonight was
- 3 regarding, I thought the electric was going up 14 percent.
- 4 If that's not the case, I guess it's not quite as big an
- 5 issue as that.
- JUDGE HOPKINS: Who is this that you
- 7 represent, sir?
- 8 THE WITNESS: The Emmaus Home is a home for
- 9 developmentally disabled adults. There are 112 people in
- 10 a campus setting in Southern Warren County. Our average
- 11 electric bill is about \$81,500 a year. So 14 percent
- 12 would be a substantial cost to us, which at this time we
- 13 can't afford. So if it's electric that we're talking
- 14 about, please don't do it. As far as gas, I'm not sure we
- 15 even have gas. I'm a new administrator, I haven't seen a
- 16 gas bill yet. And I'm not sure why we got a card. I
- 17 think we use propane.
- JUDGE HOPKINS: Any questions?
- 19 CHAIR LUMPE: I'm glad that you are relieved.
- 20 THE WITNESS: I'm very relieved, yes, 14
- 21 percent of \$81,000 is a lot.
- JUDGE HOPKINS: Commissioner Murray?
- 23 COMMISSIONER MURRAY: No questions. Thank
- 24 you.
- 25 THE WITNESS: Could I just ask why we would

- 1 have gotten a card if we don't have gas?
- 2 MR. EVANS: As I understand it the cards were
- 3 sent out to only gas customers and it should have only
- 4 gone to gas customers. So I guess you are probably a gas
- 5 customer.
- 6 THE WITNESS: All right. Anyway, we do get
- 7 excellent service from UE with our electric. I have to
- 8 say that.
- 9 JUDGE HOPKINS: Is there anyone else who
- 10 would like to testify? If there is no one else that would
- 11 like to testify --
- 12 THE WITNESS: Is there anything on the card
- 13 that said gas?
- MR. EVANS: No. There really is not, but
- 15 there is a reference to --
- 16 (Thereupon, a short recess in the proceedings was
- 17 had.)
- JUDGE HOPKINS: All right. Thank you. We're
- 19 back on the record. There was a discussion off the record
- 20 about the notice. We had a gentleman that was here under
- 21 the impression that it was an electric card. If there is
- 22 no other testimony from anyone, anybody else want to
- 23 testify? Well, we certainly appreciate all your interest.
- 24 Yes, ma'am, did you want to testify?
- THE WITNESS: Please.

1 JUDGE HOPKINS: Come on up here.

- 3 DORIS CLARK,
- 4 of lawful age, being first duly sworn to tell the truth,
- 5 the whole truth, and nothing but the truth, deposes and
- 6 says on behalf of the Public Service Commission, as
- 7 follows:
- 8 TESTIMONY
- 9 JUDGE HOPKINS: Would you please be seated
- 10 and spell and state your name for the court reporter.
- 11 THE WITNESS: My name is Doris Clark,
- 12 C-1-a-r-k.
- JUDGE HOPKINS: Thank you. Go ahead.
- 14 THE WITNESS: Okay. Probably like many, I am
- 15 a single, self-supporting, and live pretty well on a fixed
- 16 income other than a lot of volunteering and helping a lady
- 17 83 years old. And other than that, I would be living off
- 18 of approximately \$400 and some a month. And I do not -- I
- 19 have never understood -- I have had people -- is this just
- 20 gas or may I tie in other electric; or I'm not free to do
- 21 that.
- 22 JUDGE HOPKINS: Well, this is just a hearing
- 23 on the gas increase. And so a statement about electricity
- 24 would be irrelevant -- I mean, we can't do anything pro or
- 25 con.

1 THE WITNESS: Well, I had received one of the

- 2 cards. I am a gas user apparently here in the City of
- 3 Wentzville. And from what I'm understanding, this would
- 4 take my bill up another \$10. Am I understanding this
- 5 correctly? Which is a hardship on me with the combination
- 6 of my gas and electric, which they just turned around and
- 7 raised. Now, you understand I am not in my house five
- 8 days a week. I have never been able to understand. I
- 9 have had meters put on things. I have done the whole bit.
- 10 Nobody can understand where my electric is going or
- 11 anything else. But as far as where my -- I am average in
- 12 like \$84 with a combination here and no one in the house
- 13 but like Saturdays and Sundays and evenings. And to me
- 14 this is just totally, utterly ridiculous. Another \$10
- 15 stuck on this is a problem to me with what I previously
- 16 told you as far as maintaining and trying to keep things
- 17 up for myself. And this is a difficult situation. And
- 18 where maybe \$10 don't mean a lot to some people, when it
- 19 comes to my monthly bills it means a lot to me.
- JUDGE HOPKINS: All right. Thank are you
- 21 very much.
- 22 CHAIR LUMPE: I want to thank you for coming
- 23 and participating and testifying. We appreciate hearing
- 24 your comments.
- THE WITNESS: Okay.

JUDGE HOPKINS: Commissioner Murray?
```

- 2 COMMISSIONER MURRAY: Yes. Is AmerenUE your
- 3 gas and electric provider?
- 4 THE WITNESS: Yes.
- 5 COMMISSIONER MURRAY: If you did have
- 6 anything that you wanted to say about the quality of
- 7 service for gas or electric we would certainly hear that
- 8 tonight. You were not wanting to complain about the
- 9 quality of service, were you?
- 10 THE WITNESS: No, I kind of help maintain --
- 11 help you all maintain the service around town. I'm one of
- 12 these people when the street lights are out it drives me
- 13 crazy and I never see them getting maintained. So I call
- 14 the Company and say: This light is on such and such. And
- 15 I have had a lot of promises throughout the City that they
- 16 are going to check with AmerenUE about setting up a pole
- 17 close to me where -- my neighborhood has become not too
- 18 great an area. And I am -- where I am situated, I'm in
- 19 the dark when I drive up. I am not comfortable with where
- 20 I live any more because I do not have the lighting I need.
- 21 And this has supposedly been looked into
- 22 years ago but it's never got off the ground. Nothing has
- 23 ever happened. Promises, promises, but nothing has ever
- 24 been fulfilled. And I am very uncomfortable coming home
- 25 at night. I have found my door ajar a couple of times. I

1 had to go to the Police Department because I was afraid to

- 2 go in. Just things that -- it is very dark on my street.
- 3 A light is around the corner from me and shines to the
- 4 corner, but when you come around that corner the next
- 5 light is pretty far down so I am not getting the benefit
- 6 of that. And in the back they have, like, knocked out the
- 7 light with rocks or whatever before. But I usually, when
- 8 something is out, I usually call the Company and ask them
- 9 if they'll please check it out. I don't think the light
- 10 up on Lynn and South Main has been done yet. And I called
- 11 them about two weeks ago.
- 12 COMMISSIONER MURRAY: Do you ordinarily get a
- 13 pretty quick response when you call?
- 14 THE WITNESS: You mean, as far as on the
- 15 phone or as far as the maintenance?
- 16 COMMISSIONER MURRAY: Who do you call and
- 17 report there is an outage somewhere?
- 18 THE WITNESS: Well, I have and I haven't -- I
- 19 mean, I know that's double talk, but I have at times and
- 20 then there are other times I have not.
- 21 COMMISSIONER MURRAY: Thank you.
- THE WITNESS: You're very welcome.
- JUDGE HOPKINS: General Counsel.
- MR. SNODGRASS: Yes, ma'am. I'm Cliff
- 25 Snodgrass, I'm with the staff of the Missouri Public

```
1 Service Commission. And there are some pink cards over
```

- 2 there for consumer complaints. An 800 hot line. And if
- 3 there is anything that's within our jurisdiction that we
- 4 can look into for you, please feel free to call us. We
- 5 take these complaints and inquiries seriously. And we
- 6 will look into them for you. And I would encourage you to
- 7 pick up one of these cards. That's all I have.
- 8 THE WITNESS: I have a question, may I?
- 9 JUDGE HOPKINS: What's the question?
- 10 THE WITNESS: How often are the meters
- 11 actually checked to make sure that they are accurate?
- 12 JUDGE HOPKINS: You can talk to our Staff
- 13 Counselor, Mr. Snodgrass, and if we don't have someone
- 14 here who can answer that question tonight because I had
- 15 the same question, by the way. And I know that there are
- 16 people in the Public Service Commission that can answer
- 17 that question and they will be happy to answer it for you.
- 18 If we don't have one of those people here tonight --
- 19 you're talking about either gas or electric, we can help
- 20 you with either or both of them.
- 21 Also, AmerenUE has their technical people
- 22 here tonight, and they would be glad to explain to you
- 23 about how those meters work. That's a very good question
- 24 because I've asked the same thing myself. So we have
- 25 people that will either answer you here tonight, or you

1 can call and get a real human being at the Public Service

- 2 Commission, and we will be happy to answer that for you.
- 3 Okay?
- 4 THE WITNESS: Okay. Thank you.
- 5 JUDGE HOPKINS: It's a very good question.
- 6 THE WITNESS: Thank you.
- 7 JUDGE HOPKINS: UE?
- 8 MR. EVANS: This is not an electrical, we
- 9 would certainly like to help answer your question about
- 10 the lighting, as far as the other neighborhood question.
- 11 I would like to come see you afterwards.
- 12 THE WITNESS: Okay.
- JUDGE HOPKINS: Public Counsel?
- 14 MR. DANDINO: Ms. Clark, you talked about how
- 15 you were concerned that you were only in the house
- 16 Saturdays and Sundays and on the weekends. And yet, you
- 17 know, you are still concerned about the utility costs; is
- 18 that correct?
- 19 THE WITNESS: Right. That's correct.
- 20 MR. DANDINO: And I don't know if you are
- 21 aware but in the testimony that was filed in this case
- 22 that the customer service charges, the basic charge that
- 23 every residential customer is given, the Company is
- 24 proposing an increase from \$8.00 to \$14.00 a month.
- 25 What's your reaction to that?

```
1 THE WITNESS: I think it's too darn much.
```

- 2 MR. DANDINO: What does your gas bill usually
- 3 run during the summer -- let's say the winter?
- 4 THE WITNESS: Honestly, I didn't grab one of
- 5 those. I'm not sure at this point. I have the one I just
- 6 paid.
- 7 MR. DANDINO: Sure. How much is that?
- 8 THE WITNESS: Which, again, it's a combined
- 9 bill with electric and gas, but it's running like \$12.75 a
- 10 month. And I'm like that lady back there, I really have
- 11 nothing on it to make it \$12.75. I'm running a water
- 12 heater. And I don't know what else -- you know, why it
- 13 would be, you know, other than in the wintertime my
- 14 electric and stuff, and then the combination of the bill,
- 15 which is like \$84.00, which I'm really upset for the fact
- 16 that AmerenUE just got through saying: Well, Okay. To
- 17 make this come out we're raising you another \$1.00 or
- 18 whatever it was, \$2.00, whatever it was because I was
- 19 \$82.00 and they bumped me up another \$2.00. And I'm
- 20 thinking: Wow, wait a minute. I'm doing nothing
- 21 different. Nothing has changed. I still live in this
- 22 house by myself. I'm still here the same amount of time
- 23 as I was three years ago. What is going on here?
- MR. DANDINO: Are you on a budget plan?
- THE WITNESS: Yes, sir.

```
1 MR. DANDINO: So now you're saying
```

- 2 essentially in the winter you will be paying close to
- 3 \$84.00 a month?
- 4 THE WITNESS: Oh, I am. That's my budget
- 5 billing, period.
- 6 MR. DANDINO: Okay. So the increase and the
- 7 customer service charge would add another month's bill to
- 8 you for your \$72.00?
- 9 THE WITNESS: Okay.
- 10 JUDGE HOPKINS: Do you understand the
- 11 question?
- 12 THE WITNESS: I thought he was making a
- 13 statement.
- 14 MR. DANDINO: It should have been asked as a
- 15 question.
- 16 JUDGE HOPKINS: If she doesn't understand the
- 17 question, I don't. If you could reask the question.
- MR. DANDINO: That's all right. I'll pass on
- 19 that. Thank you very much.
- THE WITNESS: You're very welcome. May I be
- 21 excused?
- JUDGE HOPKINS: Yes, ma'am. We certainly
- 23 appreciate your coming.
- 24 THE WITNESS: Thank you.
- JUDGE HOPKINS: Anyone else? Well, thank you

```
very much. We're going to close this local public hearing
 2
     tonight. And we certainly appreciate all the people who
 3
     came up to testify. That's what we came here to do. And
     the Commission always wants me to emphasize that we have
     not decided this case and the Commissioners that are not
 5

    here will read this testimony. We're having five
     different hearings throughout the State. And they'll take
