**TRUE-UP NOTIFICATION OF  
KANSAS CITY POWER & LIGHT COMPANY AND  
KCP&L GREATER MISSOURI OPERATIONS COMPANY**

Kansas City Power & Light Company (“KCP&L”) and KCP&L Greater Missouri Operations Company (“KCP&L-GMO”) (collectively, the “Companies”) hereby provide to the Missouri Public Service Commission (“Commission”) notification that the Companies will not seek to extend the true-up period beyond the December 31, 2010 date set forth in the Commission’s *Order Approving Nonunanimous Stipulation And Agreement, Setting Procedural Schedule, And Clarifying Order Regarding Construction And Prudence Audit* (“*Procedural Order*”) issued on August 18, 2010 in the above-captioned proceedings.

In support hereof, KCP&L and GMO state as follows:

1. On August 18, 2010, the Commission issued a *Procedural Order* in the above-captioned proceedings that established a true-up date for these rate cases of December 31, 2010, but enabled the Companies to request that the true-up date be extended if necessary, citing the uncertainty related to the Companies’ in-service date of the Iatan 2 Generating Station.

2. The Commission directed the Companies to submit a notification in these proceedings by no later than October 6, 2010 if they sought to extend the true-up date. The Companies hereby notify the Commission that they do not seek to extend the true-up period in these cases beyond the December 31, 2010 date established in the *Procedural Order*.
