## ORDER AMENDING SCHEDULE AND DIRECTING FILING

Issue Date: July 11, 2011 Effective Date: July 11, 2011

The Missouri Public Service Commission is amending the procedural schedule pursuant to the *Joint Motion to Extend Discovery Period and Modify Procedural Schedule* ("joint motion").

Nexus Communications, Inc., ("Nexus") and Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri ("ATT"), filed the joint motion on July 8, 2011. In the joint motion, Nexus and ATT state that Staff has no objection. Because the Office of Public Counsel has made no appearance, the Commission will waive the regulatory response period.<sup>1</sup>

Nexus and ATT ask for an order denying [Nexus]'s Motion to Extend Discovery Period. The joint motion constitutes the response of ATT to, and renders moot, [Nexus]'s Motion to Extend Discovery Period. The Commission will grant that request.

Nexus and ATT also ask for an order and suspending the date set in the June 28

Order Setting Deadline for Filing Motions Regarding ADR Clause. The Commission will

grant that request. The Commission will also direct the filing of proposed deadlines for filing such motion.

- 4. The date set in the June 28 Order Setting Deadline for Filing Motions Regarding ADR Clause is suspended. No later than July 21, 2011, Nexus

Communications, Inc., ("Nexus") and Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri ("ATT") shall file proposed deadlines for filing any motion seeking relief based on any dispute resolution provision in the interconnection agreement between ATT and Nexus. Any other party may make such filing by such date.

- 5. Nexus Communications, Inc.'s Motion to Extend Discovery Period is denied as moot.
- 6. The pre-hearing conference and evidentiary hearing will begin at 9:00 A.M. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The pre-hearing conference and evidentiary hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act and any person who needs additional accommodations to participate in the pre-hearing conference or evidentiary hearing shall contact the Commission before such event.
