On August 15, 2022, Fidelity Cablevision, LLC d/b/a Fidelity Communications (Company) filed a request to relinquish portions of its Eligible Telecommunications Carrier (ETC) designation. The Company wishes to partially relinquish its ETC designation for the Rural Digital Opportunity Fund (RDOF) so that it will retain RDOF ETC designation only in those areas for which it will receive RDOF funding. In addition, the Company requests removal of certain census block groups from its RDOF ETC designation.

The Company also wishes to relinquish the additional Lifeline ETC designation granted by the Commission in File Nos. CA-2021-0282 and CA-2021-0415.

The Commission will direct its Staff to file a recommendation.
