**ORDER GRANTING MOTION TO MODIFY ORDER**

Issue Date: February 24, 2010

Effective Date: March 6, 2010

On November 23, 2009, the Commission issued an order approving the Company/Staff Agreement Regarding Disposition of Small Sewer Company Revenue Increase Request ("Agreement") between the Staff of the Commission and Gladlo Water & Sewer Company, Inc., and directed Gladlo to comply with the Agreement's terms. The order became effective on November 30, 2009.

Condition (9) of the Agreement required that Gladlo would file with the Missouri Secretary of State ("SOS") necessary documents to obtain a Certificate of Good Standing. These documents were to be filed no later than January 31, 2010. In addition, Gladlo was required to file additional documents with the SOS 30 days later (March 2, 2010).

Staff filed a motion to modify the Commission's order on February 18, 2010. Gladlo's receiver filed the necessary documentation to receive a Certificate of Good Standing on February 9, 2010. The delay was caused by unforeseen problems in receiving a tax clearance from the Missouri Department of Revenue, which is a prerequisite to filing for reinstatement with the SOS. The receiver will notify Staff when its Reinstatement and Certificate of Good Standing is issued.

Staff believes Gladlo has met the spirit of Condition (9) of the Agreement but, due to unforeseen circumstances, was unable to meet the January 31, 2010 deadline. Staff requests that the Commission approve modification of the provision to give Gladlo until March 31, 2010, to complete Condition (9). Gladlo supports Staff's request. No responses to the motion were filed.

The Commission has considered Staff's motion and finds it is reasonable to grant Gladlo an extension of time to complete Condition (9) of the Agreement.

**THE COMMISSION ORDERS THAT:**

1. Staff's Motion to Modify Order Approving Small Company Rate Increase and Approving Tariffs is granted.
2. Gladlo Water & Sewer Company, Inc., is granted an extension of time until March 31, 2010, in which to complete Condition (9) of the Company/Staff Agreement Regarding Disposition of Small Sewer Company Revenue Increase Request.
3. This order shall become effective on March 6, 2010.
4. The case may be closed on March 7, 2010.
