ORDER GRANTING EXTENSION OF TIME WITH MODIFICATIONS, MODIFYING BRIEFING SCHEDULE AND SETTING HEARING DATE

The Commission's Staff has requested an extension of time to notify the Commission whether Staff will seek further enforcement of certain subpoenas. The requested extension is sought because the individuals and entities subject to the subpoenas have been providing information with affidavits and Staff expects additional affidavits to be submitted this week. The Commission finds Staff's request reasonable and grants an extension until Monday June 7, 2010. But, the Commission recognizes the operation of law date for this case is approaching and the evidentiary record must be closed at a reasonable time in order to allow the Commission time to render a final decision. Consequently, there will be no further extensions.

Additionally, because the affidavits submitted, and potentially other documents accompanying the affidavits, have not yet been offered into the evidentiary record, the Commission will grant Staff's request to set a date and time for an evidentiary hearing for

that specific purpose. And because the affidavits have largely centered on the issue of availability fees, the Commission will modify the current schedule for briefing.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission's request for an extension of time to notify the Commission of the status of the subpoenas served on Peter N. Brown, Cynthia Goldsby, RPS Properties, L.P., Sally Stump, Vernon Stump and John Summers is extended until June 7, 2010. No further extensions of time will be granted.

2. The following modifications to the procedural schedule are established:

3. The Commission gives notice that it will hold an evidentiary hearing on June 24, 2010, beginning at 8:30 p.m., in Room 310 at its offices in Jefferson City.

4. The evidentiary hearing shall be held in a facility that meets the accessibility requirements of the Americans with Disabilities Act.
