- 1. On February 17, 2004, the Staff of the Missouri Public Service Commission ("Staff") initiated a complaint pursuant to Section 386.390 and 4 CSR 240-2.070 against Officeplus for failure to file an annual report pursuant to the requirements of 392.210.1 RSMo.
