<u>APPLICATION TO INTERVENE OF</u> NAVIGATOR TELECOMMUNICATIONS, LLC

Comes now Navigator Telecommunications, LLC ("Navigator"), by its undersigned attorneys, and pursuant to 4 CSR 240-2.075 applies to intervene in the captioned proceeding. In support of this application, Navigator states the following:

1. Navigator Telecommunications, LLC, is an Arkansas limited liability company, authorized to do business in the state of Missouri. Its principal place of business is located at 8525 Riverwood Park Drive, P. O. Box 13860, North Little Rock, Arkansas 72113, telephone number (501) 954-4000, facsimile number (501) 954-4002, and its email address is mike@navtel.com. Navigator is an authorized provider of basic local exchange, local exchange, and interexchange telecommunications services in Missouri, pursuant to certificates granted in Case Nos. TA-2000-232 and TA-2000-243. Navigator's interconnection agreement with Southwestern Bell Telephone Company was approved by the Commission by Order dated November 22, 1999, in Case No. TO-2000-291. In March, 2001, Navigator adopted the Missouri 271 interconnection agreement with SBC ("M2A" or "the Agreement"), which the Commission had approved in Case No. TO-99-227. Navigator requests that the Commission take notice of the Agreement and all amendments thereto, which are contained in the Commission's files.

3. This application to intervene is timely, as it is filed prior to the Commission's issuance of an order giving notice of the case, in compliance with 4 CSR 240-2.075(1).

4. Navigator's interest in this proceeding is based on the fact that it is party to the M2A, which is the subject matter of the formal complaint. Navigator is concerned that certain Accessible Letters which SBC has recently issued, and which are attached as exhibits to the formal complaint, are intended to unilaterally amend the M2A in a manner inconsistent with the terms of the Agreement.

5. As required by 4 CSR 240-2.05(2), Navigator states that it supports the relief sought in the formal complaint.

6. The interest which Navigator has in the subject matter of this proceeding is different from the interest of the general public, and may be adversely affected by a final order in this proceeding.

7. A copy of Navigator's Certificate to do Business in the state of Missouri is attached hereto as Exhibit "A."
