MOTION FOR STAY TO INCLUDE NAVIGATOR TELECOMMUNICATIONS, LLC

Comes now Navigator Telecommunications, LLC ("Navigator"), and pursuant to Chapter 392.250 RSMo., moves the Commission to extend the stay and Order Requiring Continued Provisioning of Service, issued in this proceeding on March 10, 2005, to Navigator. In support of this motion, Navigator states the following:

- Navigator filed its Application to Intervene in this proceeding on March 8, 2005.
 The Commission issued its Notice of Complaint on March 9, 2005.
- 2. On March 10, 2005, the Commission issued its Order Requiring Continued Provisioning of Service ("the Order"), mandating the continued provision by the Respondent of certain services to competitive local exchange carriers in Missouri.
- 3. Navigator believes that the Order already protects Navigator against the loss of the services specified Ordered paragraph 1, but out of an abundance of caution, and if the Commission believes such action must be taken, Navigator moves the Commission to specifically apply the Order to Navigator as well.

4. Unless the Commission already believes that the Order extends to Navigator, the telecommunications industry in Missouri will be faced with a situation in which many competitive local exchange carriers will not have the protection of that order. Absent application of order to Navigator, the company would suffer irreparable harm pending resolution of the issues in this proceeding.

Wherefore, Navigator Telecommunications, LLC respectfully requests that the Commission forthwith extend the Order Requiring Continued Provisioning of Service to Navigator.
