## NOTICE CLOSING CASE

Issue Date: November 6, 2008

On September 18, 2008, the Missouri Public Service Commission issued an order cancelling Winstar Communications, L.L.C.'s certificate. Concerned about Winstar's customers, the Staff of the Commission then filed a motion to transfer those customers to AT&T Missouri. The Commission then joined AT&T as a party and directed the company to respond to Staff's motion.

On October 22, AT&T filed its response stating that there are no longer any end-users utilizing the facilities that AT&T Missouri had been providing to Winstar on a wholesale basis. In light of AT&T's filing, Staff's motion is moot. There remains no further action in this matter. This case is therefore closed.
