COMES NOW Mid-Missouri Telephone Company, Complainant herein, pursuant to 4 CSR 240-2.116, and notifies the Commission and all parties that Mid-Missouri Telephone Company is hereby dismissing its Complaint without prejudice to the refiling thereof. Mid-Missouri Telephone Company has discussed this Dismissal with Southwestern Bell Telephone Company, the adverse party herein, and has obtained Southwestern Bell Telephone Company's written consent to this Dismissal, which is attached hereto.

Mid-Missouri Telephone Company for the past several weeks has been involved in an extraordinary matter consuming inordinate amounts of management's time, and this matter is expected to continue for several more weeks.

Mid-Missouri has requested to be provided with all traffic data SWBT possesses for the September 12, 2002 traffic terminating to Mid-Missouri. SWBT has refused to provide the data other than for calls Mid-Missouri specifically identified as prohibited calls. Without this information Mid-Missouri cannot reconcile its switch recordings with records provided by other

carriers. There remain issues associated with other types of traffic as set forth in prefiled testimony. SWBT was unwilling to agree to a continuance for further discovery in this regard, but did agree to meet informally with Mid-Missouri to discuss resolution of the issues if this dismissal was filed.
