The parties are expected to appear on October 20, 2016 at 8:30 a.m. in order to present information and answer questions regarding the Stipulation and Agreement filed in this matter. The Commission informs the parties that the following information is specifically requested and will direct the Staff of the Commission to prepare a written exhibit with that information. Any other party may present a similar document.

- A. What are the actual annual revenues received by the company during the Test Year?
- B. What is the current revenue requirement for the company?
- C. What are the current rates?
- D. What is the percentage increase in revenue requirement?
- E. What are the new rates? And what is the new rate design?
- F. What is the percentage increase in rates?

THE COMMISSION ORDERS THAT:

- 1. The Staff of the Missouri Public Service Commission shall prepare a document answering the above questions to be presented at the on-the-record presentation on October 20, 2016.
- 2. Any other party may also prepare such a document.
