SECOND JOINT MOTION FOR EXTENSION OF TIME TO FILE INTERCONNECTION AGREEMENTS

COME NOW CenturyTel of Missouri, LLC, and Spectra Communications Group, LLC (collectively, "CenturyTel") and Socket Telecom, LLC ("Socket") (collectively "Joint Movants"), pursuant to Commission Rule 4 CSR 240-2.050(3), and for their Second Joint Motion for Extension of Time to File Interconnection Agreements, state as follows:

- 1. Pursuant to Commission Rule 4 C.S.R. §240-36.050, and the Commission's July 6, 2006, Order Granting Motion for Extension of Time to File Interconnection Agreement, in the absence of agreement, the Joint Movants would be required to file the conforming Interconnection Agreements no later than August 18, 2006.
- 2. Joint Movants are in the process of creating "conforming" Interconnection Agreements that incorporate the Commission's decisions on each of the contested issues, and have made significant progress, but because of the scope of the project have not been able to complete the work in the time available.
- 3. The Joint Movants expect that they will be able to produce final agreements and file same with the Commission by August 25, 2006, and request the Commission extend the deadline accordingly.

WHEREFORE, Joint Movants respectfully request the Commission to extend the deadline for filing Interconnection Agreements set forth in 4 C.S.R. §240-36.050 as requested herein and for such other orders as are appropriate in the circumstances.
