# Basis of complaint

As the basis of this complaint, Complainant states the following facts:

Starting in March 2003, phone calls to a number in O'Fallon, IL (618-628-2724) began to appear on my business phone bill. I have two lines at home that I use for my graphic design business, Plum Studio. These numbers are 314-725-2430 (phone) and 314-725-2460 (fax).

From March – July, approximately \$1378.18 in calls to 618-628-2724 appeared on my bill. Most of these calls came from my fax number, a few from my phone number. Many of these calls occurred at a time when no one was at home. I am unfamiliar with this number, other than seeing it on my monthly bill. Please see the phone bills from March – July.

According to my March bill, the first seven calls to O'Fallon were made on February 18, beginning at 10:39pm. As documentation from American Airlines will confirm, I was in New York City on business at that time. It is not possible that I could have made these calls.

I have spoken with SBC many times since this issue began. Initially, they suggested that I place a padlock on my phone box outside. I complied with this request. When the calls continued to occur, it was suggested that I replace my fax machine (just one year old). I did that and the bill continued to reflect calls to O'Fallon. Finally, I unplugged my fax machine in late March and left it unplugged until early May. My bill reflected calls made to the O'Fallon number, even while my fax machine was unplugged. The inability to use my fax machine (while paying for phone service to the line) was a major inconvenience.

It has also been suggested that my internet service was somehow the culprit for this problem. However, I do not have a dial-up account, and my dsl account (not with SBC) runs from my home phone line (314.727.6335).

While SBC repeatedly told me that technicians could find no problems on the line, I did finally receive a call in early May (shortly before I reattached my fax machine) that claimed that the problem was SBC's after all, and that my account would be credited. I was given no phone number to respond. On my June bill, I received a credit of \$898.24 (which was applied May 20).

However, my July bill reflected further calls to O'Fallon made as late as May 28, after SBC claimed to have repaired my line. It was clear that SBC had not solved

the problem. SBC has consistently refused to apply a second credit, or to explain what problem they believe they solved in issuing the first credit.

I requested that SBC investigate this matter further, and beyond having a technician check the line one last time, they have refused.

I have spent no less than fifteen hours on the phone with SBC over the past six months, and countless hours documenting and reviewing the problem, to say nothing of the major inconvenience that this has caused my business.

# **Relief Requested**

The total dollar value billed to me for calls made to O'Fallon is \$1378.18. Of that, SBC has credited me a total of \$898.24. I wish to be credited for the balance of \$479.94, which is currently in claims.

I also believe that I am owed some reassurance that the lines that SBC is providing me are, in fact, secure. It would appear that this is not the case.

# Attempts to work with Respondent

On numerous occasions, I have requested that a credit be issued to me. Alan Beliston in the Regulatory Department was the most recent person to deny this to me twice. I have spoken to no less than 10 people in the company, few of whom have had voicemail or email, so it has been possible to follow up with them.

In every case that I have been in a position to ask for reparations, they have been refused.

This letter is in response to the complaint you filed against SBC Long Distance and your indication that you wish to file a formal complaint.

A formal complaint must be filed in written form including an original and eight (8) copies addressed to:

Secretary of the PSC ATTN: Data Center PO Box 360 Jefferson City MO 65102-0360

After filing, the Commission will give the company thirty (30) days to either satisfactorily resolve the complaint or respond in writing with the company position. If the complaint is not settled and the company responds denying the allegations, the Commission may order the Staff to conduct an investigation and may schedule a hearing.

The hearing is very similar to a trial in a court of law. At the time of the hearing, state law requires that you present evidence, which will substantiate your claim against the company. The company also will be given the opportunity to present evidence discounting your claims. All parties, including the Commission's Staff, will have the opportunity to cross-examine the other parties witnesses. Further, any person as defined in 4CSR 240-2.010(11), other than an individual must be represented by an attorney.

Please note, further filing requirements in the enclosed Chapter 2 - Rules of Practice and Procedure.



Effective 5/21/03, the rate for residential Extra Listings, Foreign Listings and Extra Lines will change from \$1.78 to \$1.92 per listing. The rate for Personality Logo Directory Listings will decrease from \$4.50 to \$4.25. The price for Family Space Listings will decrease from \$4.50 to \$4.25. The rate for business Extra Listings, Foreign Listings and Extra Lines will change from \$2.85 to \$3.07 per listing.

Effective 5/21/03, the rate for direct-dialed National Directory Assistance (NDA) will change from \$1.10 to \$1.18 per call. The alternately billed (such as calls billed to a calling card) NDA rate will change from \$1.18 to \$1.27 per call. The rate for direct-dialed Reverse Directory Assistance (RDA) will change from \$1.25 to \$1.50 per call. The alternately billed RDA rate will change from \$1.40 to \$1.70 per call. One NDA/RDA search is provided per charge. There are no call allowances (calls made to directory assistance without a charge) or exemptions with NDA/RDA services.

Effective May 21, basic local toll rates will be changing. The new day rate will be 25




