ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: June 5, 2007 Effective Date: June 23, 2007

On August 30, 2006, Big River Telephone Company, L.L.C. ("Big River") applied for a certificate of service authority to provide basic local exchange telecommunications services in portions of Missouri that are being served by BPS Telephone Company ("BPS"), and for competitive classification. An evidentiary hearing was held in this matter on February 13, 2007, and the Commission issued its final Report and Order on April 24, bearing an effective date of May 4. In that Order, the Commission granted Big River's application subject to certain conditions including that Big River "file with the Commission updated tariff provisions clearly identifying the services and rates offered to its customers for all of its telecommunications services and correcting all deficiencies in its current tariff as delineated in the body of this order."

¹ All dates from this point forward throughout this order refer to the year 2007 unless otherwise noted.

On May 24, Big River submitted proposed revisions to its Tariff No. 2 regarding local and exchange access; Tariff No. YL-2007-0855, bearing an effective date of June 23. On May 25, Big River submitted additional proposed revisions to its Tariff No. 2; Tariff No. YL-2007-0861, bearing an effective date of June 24. On May 29, Big River filed a substitute revised sheet for its Tariff No. 2, First Revised Sheet Page 61, with additional corrections to its original May 25 filing.

On June 4, the Staff of the Missouri Public Service Commission filed its recommendation and verified memorandum. Staff finds the tariff sheets to be in compliance with the Commission's Report and Order and recommends that the Commission approve the submitted tariffs, or to allow them to go into effect by operation of law on their effective dates. The Commission has reviewed the tariff filings and Staff's verified recommendation and memorandum, which is hereby admitted into evidence, and finds that Big River's tariffs should be approved. Because of limitations of the Commission's Electronic Filing and Information System, each tariff will be approved by separate order.

IT IS ORDERED THAT:

1. The tariff sheets filed by Big River Telephone Company, L.L.C. on May 24, 2007, pursuant to the Commission's April 24, 2007 Report and Order, assigned Tariff No. YL-2007-0855, are approved to become effective on June 23, 2007. The tariff sheets approved are:
