On December 7, 2021, Ozark Fiber, LLC (“the Company”) pursuant to Section 392.550, RSMo, filed an application for certificate of service authority to Provide Basic Local Telecommunications Service and Non-Switched Local Telecommunications Service in the following exchanges:

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo.
