**ORDER APPROVING AND RECOGNIZING NEW MEMBER OF THE
RELAY MISSOURI ADVISORY COMMITTEE**

On October 24, 2022, the Staff of the Commission filed a motion asking the Commission to approve the appointment of a new member to the Relay Missouri Advisory Committee. Staff asks the Commission to approve and recognize Becky Davis as the Executive Director of the Missouri Commission for the Deaf and Hard of Hearing (MCDHH) to fill the permanent MCDHH position on the Relay Missouri Advisory Committee. Staff explains that the MCDHH position is one of five permanent positions on the Committee. Persons assuming a permanent position on the Committee do not require a Commission vote to become members of the Committee. Instead, the new permanent committee member needs only Commission recognition and approval.

The Commission will recognize and approve Becky Davis as a permanent member on the Committee.

So the recognition and approval will take effect as soon as possible, the Commission will give this order a ten-day effective date.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes and approves Becky Davis, Executive Director of the Missouri Commission for the Deaf and Hard of Hearing to fill the permanent MCDHH position on the Relay Missouri Advisory Committee.
2. This order shall become effective on November 19, 2022.
3. This file shall be closed November 20, 2022.
