## AMERICAN BROADBAND AND TELECOMMUNICATIONS COMPANY'S MOTION TO AMEND APPLICATION

American Broadband and Telecommunications Company ("Applicant" or the "Company"), by its counsel, respectfully submits this amendment to its Application for Designation as an Eligible Telecommunications Carrier for the Limited Purpose of Offering Lifeline Service on a Wireless Basis (the "Application"), and states to the Missouri Public Service Commission ("Commission") as follows:

1. On March 7, 2014, an Application to Intervene, Notice of Opposition, and Request for Hearing (the "Intervention") was filed in this matter. The Intervention took no position as to Applicant's request to be designated as an eligible telecommunications provider, but instead opposed any grant of authority that would allow Applicant to offer Lifeline service under the "American Broadband" name in Missouri. The Intervention further clarified that it did not oppose Applicant's use of the "American Assistance" name to provide its Lifeline services in Missouri.

2. Without waiving any objections to the Intervention and while specifically reserving its rights related to the subject matter therein, Applicant states that it intends to advertise, market and offer its Lifeline service offerings in Missouri under the "American Assistance" brand name. Consistent with that approach, Applicant has registered the "American Assistance" name as a fictitious name with the Secretary of State of Missouri. *See* Exhibit A.

3. Applicant hereby requests that the Commission amend the Application to request designation as an eligible telecommunications carrier under the "American Assistance" name. Further, Applicant requests that the Commission deny the Intervention as moot, in light of this motion.

WHEREFORE, American Broadband and Telecommunications Company hereby respectfully requests that the Commission issue an order granting this motion to amend the Application and denying the March 7, 2014 Intervention in light of this motion, together with such other and further relief as the Commission deems just and proper.
