# Executive Officers' Qualifications and Experience Company's Telecommunications Background



### John Marsch, Chief Executive Officer

John Marsch is the C.E.O. and founder of TMC Communications. TMC is the latest successor to TMC of California (TMC Cal), a telecommunications company founded by Mr. Marsch in 1982. TMC Cal was one of the first long distance resellers in California. Under Mr. Marsch's leadership, TMC grew to become the largest reseller in California in 1990, with a commercial customer base of over 14,000 customers and monthly revenues of over \$3.5 million. Mr. Marsch sold the company in 1990 to a Swiss financial holding company for what was then thought to be the highest revenue multiple in the industry for a privately held company. In the same year, Mr. Marsch was nominated as Entrepreneur of the Year for the greater Los Angeles area. In 1996, he wrote the business plan and
