**ORDER RECOGNIZING NAME CHANGE**

On January 23, 2023, CenturyTel of Missouri, LLC d/b/a CenturyLink, CenturyTel of Northwest Arkansas, LLC d/b/a CenturyLink, and CenturyTel Broadband Services, LLC filed notice indicating they have changed their names to Brightspeed of Missouri, LLC, Brightspeed of Northwest Arkansas, LLC, and Brightspeed Broadband, LLC respectively. The companies also filed tariff changes to adopt the new name. On February 8, 2023, the Commission’s Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name changes.

The Commission will recognize the name change. The tariff changes to adopt the name changes will be allowed to take effect by operation of law.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of CenturyTel of Missouri, LLC d/b/a CenturyLink, CenturyTel of Northwest Arkansas, LLC d/b/a CenturyLink, and CenturyTel Broadband Services, LLC to Brightspeed of Missouri, LLC, Brightspeed of Northwest Arkansas, LLC, and Brightspeed Broadband, LLC respectively.

2. This order shall be effective on March 11, 2023.
