#### **STAFF RECOMMENDATION**

The parties submitted the proposed Amendment to the Missouri Public Service Commission (Commission) pursuant to the terms of the Telecommunications Act of 1996 (Act). Staff has reviewed the proposed Amendment and believes it meets the limited requirements of the Act. Specifically, the Amendment: 1) does not discriminate against telecommunications carriers not party to the amended Agreement and 2) is not against the public interest, convenience or necessity. Staff recommends the Commission direct the Parties to submit any further modifications or amendments to the Commission for approval.

**The proposed Amendment** introduces language to bring the existing Agreement between the parties into compliance with the Triennial Review Remand Order (TRRO).

Staff does not have a serially numbered copy of the Amendment and recommends the Commission direct the Parties to submit a serially numbered copy of the Amendment.
