**STAFF’S RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), through the undersigned counsel, and hereby states:

1. On August 11, 2022, the above-referenced companies Holway Telephone Company, Holway Long Distance, KLM Telephone Company, KLM Long Distance, and N.W. Communications Co. all d/b/a American Broadband submitted a letter advising that they have adopted the fictitious business name of Fastwyre Broadband. On August 15, 2022, Holway Telephone Company and KLM Telephone Company filed supplemental documents to comply with 20 CSR 4240-31.015(2).

2. Rule 20 CSR 4240-28.011(2) provides that any company with a certificate or registration that changes its name shall provide advance notice to the Commission of the name change and lays out the methods and requirements for such notice. In lieu of a Memorandum, Staff herein states that although the company does not appear to have provided advance notice of the name change, the company has complied with all

other aspects of the rule. No entities intervened to oppose the name change and the company is not delinquent in any required filings with the Commission.

3. Tariffs were submitted with the application, effective September 1, 2022. Staff has reviewed the tariff sheets and recommend that the Commission approve the tariffs or allow them to take effect by operation of law.

**WHEREFORE**, Staff respectfully recommends that the Commission recognize the name changes from Holway Telephone d/b/a American Broadband to Holway Telephone d/b/a Fastwyre Broadband; Holway Long Distance d/b/a American Broadband to Holway Long Distance d/b/a Fastwyre Broadband; KLM Telephone d/b/a American Broadband to KLM Telephone d/b/a Fastwyre Broadband; KLM Long Distance d/b/a American Broadband to KLM Long Distance d/b/a Fastwyre Broadband; and N.W. Communications Co. d/b/a American Broadband to N.W. Communications d/b/a Fastwyre Broadband; permit the revised tariff sheets to take effect; and grant such other and further relief as it finds just in the circumstances.
