(Payroll), and The Phone Connection, Inc. dba Affordable Phone Company (Affordable), Joint Applicants herein, by their undersigned counsel, and respectfully provide this Third Status Report in response to the Commission's <u>ORDER DIRECTING FILING OF STATUS REPORT</u> issued July 9, 2003:

Since the filing of the Second Status Report on May 9, 2003, the Commission has approved, on May 22, 2003, the interconnection agreement between Sprint Missouri, Inc., d/b/a Sprint, and The Phone Connection, d/b/a Affordable Phone, which had been filed on April 7, 2003 in MoPSC Case No. TK-2003-0407. The Commission also approved the adoption by Affordable of the basic local exchange tariff of Payroll Advance, Inc. by its "Order Approving Compliance Tariffs" issued May 30, 2003.

Previously, as reported in the Second Status Report, Affordable had adopted the Southwestern Bell Telephone Company M2A interconnection agreement, and the Commission had approved Affordable's interconnection and resale agreement with ALLTEL Missouri, Inc. (Case No. CK-2003-0164) and its resale agreement with Spectra

Communications (Case No. TK-2003-0221). Thus, the pieces requisite to completion of the transaction approved in this case have continued to fall into place.

The transfer of assets from Payroll Advance, Inc. to The Phone Connection dba Affordable Phone Company is about to begin, and will take up to three to four weeks to complete. Notice will be provided to customers with their next billing following transfer, and notice of completion of the transfer will be given to the Commission within ten days of completion of that transfer. Thus, the transaction approved by the Commission in this case is proceeding and will be completed in the coming weeks.
