**STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and for its recommendation states as follows:

1. On November 14, 2005, Ren-Tel Communications, Inc. ("Applicant") filed an application with the Commission for approval of a change of name to Ren-Tel Communications, Inc. d/b/a DialTone & More. In the attached memorandum, labeled Appendix A, the Staff recommends approval of the application.

2. Pursuant to 4 CSR 240-2.060(5), Applicant's request for name change clearly sets out both the old and new name to be used. In addition, Applicant has furnished a copy of the Registration of Fictitious Name that is on file with the Secretary of State.

3. In conjunction with the name change, the Applicant has submitted revised tariff sheets to its tariffs, Missouri Tariff PSC Nos. 1, 2, and 3, to reflect the name change. The Staff recommends approval of the revised tariff filing.

WHEREFORE, the Staff recommends that the Commission issue an order approving the name change and the tariff filing.
