## ORDER RECOGNIZING NAME CHANGES

Issue Date: March 13, 2023

Effective Date: April 12, 2023

On February 17, 2023, Green Hills Area Cellular Telephone, Inc. d/b/a Green Hills Telecommunications Services (File No. TN-2023-0267), Citizens Long Distance Company (File No. XN-2023-0269), Green Hills Telephone Corporation (File No. IN-2023-0270), and Citizens Telephone Company of Higginsville, Missouri, Inc. (File No. IN-2023-0271), filed notices indicating they had each adopted the fictitious name Green Hills Communication. The various companies also filed tariff changes to adopt the new names.

On March 6 and 10, 2023,<sup>1</sup> the Staff of the Commission filed responses to each application indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommended the Commission recognize the name change in each file. The Commission will do so. The Commission will also allow the submitted tariffs adopting the name change to take effect by operation of law. Additionally, the Commission acknowledges the withdrawal of the following Wireless Termination Tariffs: Green Hills Area Cellular Telephone, Inc., P.S.C. Mo. No. 3; Green Hills Telephone Corporation, P.S.C. Mo. No. 3; and Citizens Telephone Company of Higginsville Missouri, Inc., P.S.C. Mo. No. 5.

1. The Commission recognizes the name change of Green Hills Area Cellular Telephone, Inc. d/b/a Green Hills Telecommunications Services to Green Hills Area Cellular Telephone d/b/a Green Hills Communications (File No. TN-2023-0267).
2. The Commission recognizes the name change of Citizens Long Distance Company to Citizens Long Distance Company d/b/a Green Hills Communications (File No. XN-2023-0269).
3. The Commission recognizes the name change of Green Hills Telephone Corporation to Green Hills Telephone Corporation d/b/a Green Hills Communications (File No. IN-2023-0270).
4. The Commission recognizes the name change of Citizens Telephone Company of Higginsville, Missouri, Inc. to Citizens Telephone Company of Higginsville Missouri, Inc. d/b/a Green Hills Communications (File No. IN-2023-0271).
