APPLICATION OF TOLEDO AREA TELECOMMUNICATIONS SERVICES, INC. d/b/a BUCKEYE TELESYSTEM TO CANCEL ITS CERTIFICATE OF SERVICE AUTHORITY AND TARIFFS

COMES NOW Toledo Area Telecommunications Services, Inc. d/b/a Buckeye TeleSystem ("Buckeye TeleSystem") by and through its attorney and pursuant to 4 CSR 240-2.060(1) respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificate of Service Authority and Tariffs. In support of its Application, Buckeye TeleSystem states as follows:

1. Buckeye TeleSystem is a certificated interexchange carrier in Missouri with its principal place of business located at 5566 Southwyck Boulevard, Toledo, Ohio 43614. Buckeye TeleSystem, an Ohio corporation, was authorized on January 19, 2001, in Case No. TA-2001-231, to offer, render, furnish or supply interexchange telecommunication services as a reseller to the public within the state of Missouri. Buckeye TeleSystem's Certificate to Transact Business as a Foreign Corporation was filed in that docket and is incorporated herein by reference.

2. Due to a change in business plans, Buckeye TeleSystem requests the Commission to cancel its Certificate of Service Authority and Tariffs since Buckeye TeleSystem has no customers in the state of Missouri and no longer provides telecommunications services in the state of Missouri.

- 5. Buckeye TeleSystem has recently filed its Annual Report with the Commission and no assessment fees are overdue.
- 6. Cancellation of Buckeye TeleSystem's Certificate of Service Authority is not detrimental to the public interest.

WHEREFORE, Toledo Area Telecommunications Services, Inc. d/b/a Buckeye TeleSystem respectfully requests the Commission to grant its Application to Cancel its Certificate of Service Authority and Tariffs, and for any other relief appropriate in the circumstances.
