TRANSCOM ENHANCED SERVICES, INC.'S MOTION TO EXTEND DEADLINE TO FILE RESPONSIVE PLEADINGS

COMES NOW, Transcom Enhanced Services, Inc. ("Transcom") and moves to extend the deadline for all parties to file an answer or other pleadings responsive to the Complaint ("Complaint") of the Staff of the Missouri Public Service Commission ("Commission") ¹ filed in this case based on the following:

On October 16, 2012, the Staff initiated this proceeding by filing the Complaint. On October 22, 2012, the Commission entered its Order Giving Notice of Contested Case and Establishing Deadline for Answers ("Order"). The Order set the deadline for filing an answer or other pleading responsive to the Complaint as November 21, 2012. Since the filing of the Complaint, Transcom has been diligently searching for new counsel with expertise in handling the type of matters raised in the Complaint. Transcom first met with undersigned counsel on November 13, 2012.

Transcom respectfully requests that the Commission enter an order extending the deadline for all parties to file an answer or other responsive pleadings in this matter for sixty

days until January 15, 2013 because undersigned counsel has not yet had the opportunity to

review the record of the prior proceeding before the Commission (Case No. TC-2012-0331),

which forms the basis of this case (the "Blocking Proceeding"). As the Commission is aware, the

record of the Blocking Proceeding involves voluminous amounts of pleadings, testimony,

evidence, hearing transcripts, briefing, and orders that will require a significant amount of time

to review and analyze in order to be able to fully respond to the Staff's allegations in the

Complaint. Additionally, because the other party in this matter, Halo Wireless, Inc. ("Halo"), is

in bankruptcy and under the control of a Chapter 7 Trustee, undersigned counsel needs time to

coordinate with the Chapter 7 Trustee for Halo regarding the defense of this matter.

Transcom submits that the extension sought herein will not cause any prejudice or

significant delay to the Staff or any other party because the Commission has already entered an

order in the Blocking Proceeding authorizing blocking of the type of traffic that is the subject of

the present case. Further, undersigned counsel spoke with Staff Counsel, Colleen M. Dale, on

November 15, 2012, and she advised that Staff would not object to the extension being sought

herein.

WHEREFORE, premises considered, Transcom prays that the Commission enter an order

extending the deadline for all parties to file responsive pleadings in this matter for sixty days

until January 15, 2013.
