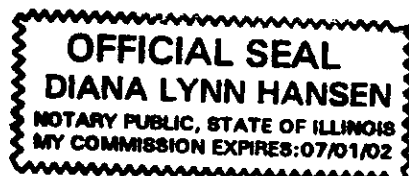

3 Direct Testimony of Sandy M. Moore

4

5 Q. Please state your name and business address.

6 A. My name is Sandy M. Moore, and my business address is 2000 W. Ameritech Center
7 Drive, Hoffman Estates, Illinois.

8

9 Q. By whom are you employed and in what capacity are you employed?

10 A. I am employed by Ameritech Corporate. I am Executive Director of Consumer Product
11 Marketing for retail Directory Services and Local Operator Assistance Services
12 ("Operator Services") for SBC. My position involves overseeing the development of
13 new products for Directory and Operator Services and product enhancements that are
14 responsive to customer needs. I also have the responsibility for developing long-term
15 product strategies for Directory and Operator Services as they relate to market and
16 competitive trends. My responsibilities require me to be familiar with the nature and
17 extent of competition faced by SBC for Directory and Operator Services. I hold this
18 position for 12 SBC states, including Missouri.

19

20 Q. Please describe your educational background and work history with SBC.

21 A. I received a Bachelor of Science degree in Business Administration from the University of
22 Illinois, Urbana-Champaign in 1988. I also earned a M.B.A. from DePaul University in
23 Chicago, Illinois in 1991.

1 I began my career with Ameritech in 1989 in the Procurement Organization, responsible
2 for material management activities. I held various positions in the Procurement
3 Organization from 1989 to 1995.

4
5 From May 1995 through January 1997, I worked as a Market Manager in the Information
6 Industry Services business unit of Ameritech, where I was responsible for managing
7 wholesale products for Directory and Operator Services for Independent Local Exchange
8 Carrier customers.

9
10 In February 1997, I joined the Corporate Product Management organization as the product
11 manager of Expanded Directory Assistance Services and Calling Card. From October
12 1997 to December 1999, I was the Product Manager for Directory Assistance Services,
13 responsible for product development and life cycle management. In December 1999, I
14 assumed the position of Director. I was promoted to Executive Director of Directory and
15 Operator Services Product Marketing in September 2000.

16
17 **Q. Have you previously participated in a regulatory proceeding?**

18 **A.** Yes. While I have not testified before the Missouri Public Service Commission
19 (Commission), I have testified before the Indiana Commission.

20
21 **Q. What is the purpose of your testimony in this proceeding?**

1 A. The purpose of my testimony is to describe the competitive landscape for Directory and
2 Operator Services and to further explain why it is appropriate for the Commission to apply
3 the same regulation to Southwestern Bell Telephone Company (SWBT) as it does to other
4 competitive telecommunications providers and therefore to acknowledge the competitive
5 classification for these services and confirm that the price cap requirements no longer
6 apply. As will be clear from my testimony, there are numerous alternatives to SWBT's
7 Directory and Operator Services and that SWBT faces effective competition for all of the
8 services falling within these categories in every SWBT exchange in Missouri. Therefore,
9 it is appropriate for the Commission to affirm the statutory intent to deem these services
10 competitive.

11

12 **Directory Services**

13 **Q. What are the main points about your testimony that the Commission should**
14 **understand relative to Directory Services?**

15 A. The Commission should understand the following points regarding Directory Services:

- 16 ▪ There are alternative providers providing substitutable services in all SWBT
17 exchanges in Missouri.
- 18 ▪ Directory Services meet the definition of effective competition and should, therefore,
19 be granted competitive classification.
- 20 ▪ Some of the alternative providers providing substitutable services existed before
21 competitive local exchange carriers (CLECs) entered the market.

- 1 ▪ Competition for Directory Services is not simply a function of access line loss
- 2 incurred by CLEC entry.
- 3 ▪ SWBT's competitors do not have the same DA regulations that exist for SWBT so
- 4 there is an unlevel playing field in this market.
- 5 ▪ Customers derive the greatest benefit from a fully competitive market where all
- 6 competitors are free to compete on equal terms.

7

8 **Directory Services**

9 **Q. Please describe SWBT's Directory Services within the state of Missouri.**

10 A. Directory Services provide callers with assistance in obtaining telephone listing

11 information. These services include: Local Directory Assistance, Directory Assistance

12 Call Completion (including AutoConnect), and National Directory Assistance.

13

14 Local Directory Assistance provides callers with listed telephone numbers of subscribers

15 who are located in the same local calling area and in the calling customer's Home

16 Numbering Plan Area (HNPA).

17

18 Directory Assistance Call Completion provides the customer the option of having the

19 local or intraLATA long distance calls automatically completed by pressing "1" after the

20 listed telephone number is received from Directory Assistance. AutoConnect is another

21 form of call completion service available to callers to Directory Assistance. However, it

1 differs in that there is no charge to the caller for the service. Rather, the Call Completion
2 charge is billed to the called Auto Connect subscriber. If the Directory Assistance caller
3 requests the telephone number of a customer subscribing to AutoConnect, the caller will
4 be advised that the call can be completed at no additional call completion charge to the
5 caller.

6
7 National Directory Assistance is a service whereby customers may obtain telephone
8 listing information for areas outside their local calling area.

9
10 **Q. Please describe the competitive nature that exists in Missouri for Directory Services.**

11 **A.** Local Directory Assistance, Directory Assistance Call Completion (including
12 AutoConnect), and National Directory Assistance are competitive throughout the state of
13 Missouri.

14 For example, alternatives to SWBT's Missouri Directory Services are provided statewide
15 by various local and toll telecommunication providers, including AT&T and
16 MCIWorldCom, as well as wireless service providers, Internet content providers,
17 directory publishers, independent Directory Services providers, software companies and
18 others. Schedule 1 provides a table of competitors and the services that they provide.

19
20 Competition in the provision of Directory Services is hardly surprising given the lack of
21 market entry barriers. For example, Directory Service listings are available to local
22 exchange and toll carriers on reasonable and non-discriminatory terms under section

1 251(b)(3) of the Federal Telecommunications Act of 1996.¹ In addition, SWBT provides
2 its Directory Service listings to non-carrier third-party Directory Service providers.

3
4 All Directory Service providers obtain listings from a variety of sources, including SWBT,
5 in order to maintain accurate databases. These sources include the provider's own listings,
6 listings of other local exchange companies, and commercially available listing
7 information. Providers of Directory Services and other functionally equivalent services
8 are able to freely copy published white page directories without copyright restrictions.²

9
10 **Q. Considering both function and price, please discuss the comparable alternatives**
11 **to SWBT's Directory Services that are available in Missouri.**

12 **A.** SWBT's residential and business customers throughout the state of Missouri have
13 multiple alternatives, substitutable in both function and price, to using SWBT's Directory
14 Services. These alternatives include:

15
16 '00' Info Service

17 This service provides end users with Local and National Directory Assistance, Call
18 Completion, category searches, and search by telephone number. To access this service,
19 the caller simply dials '00' and the call is routed to the customer's presubscribed
20 interexchange carrier.

1 For example, AT&T's "00" service was first introduced in SWBT's Missouri region in
2 February 1999. The service is available statewide to AT&T's retail residence and
3 business end users where AT&T is the presubscribed interexchange carrier. AT&T
4 promotes its service via mass marketing.³ See Schedule 2 for information on AT&T's 00
5 Information service. MCIWorldCom also offers statewide Directory Services via 00.

6
7 10-10-ATT-00

8 This service is available to all end-users within the state of Missouri regardless of
9 whether AT&T is the subscriber's presubscribed interexchange carrier. Subscribers
10 simply dial 10-10-ATT-00 to reach AT&T's Directory Services, including Local and
11 National Directory Assistance, Call Completion, category searches, and search by
12 telephone number. With availability statewide, this service is another comparable
13 alternative to SWBT's local directory service. See Schedule 2 for information on
14 AT&T's 10-10-ATT-00 service.

15
16 MCIWorldCom's 10-10-9000

17 This service provides end users throughout the state of Missouri with Local and National
18 Directory Assistance Services and Call Completion. Like AT&T, MCIWorldCom has

1 also promoted their service through mass advertising and direct mail. See Schedule 3 for
2 information on MCIWorldCom's 10-10-9000 service.

3
4 Area Code-555-1212

5 When an end user dials an area code+555-1212 and the area code is outside the caller's
6 local calling area, the Directory Assistance call is routed to the end-user's presubscribed
7 interexchange carrier's Directory Service. For example, if a customer residing in the 314
8 area code dials 816-555-1212 for Directory Assistance information, the call is routed to
9 his or her presubscribed interLATA interexchange carrier. This service is provided by
10 toll providers throughout Missouri, including AT&T, MCIWorldCom and Sprint.
11 Currently, there are over 600 interexchange service providers certificated to provide
12 service in the state of Missouri. See Schedule 4 for the Commission's list of providers.

13
14 Wireless Directory Services

15 Directory Services, including Local and National Directory Assistance, Call Completion,
16 category searches, search by telephone number, and various information services are also
17 available from wireless carriers in Missouri. Typically, wireless customers access their
18 wireless carrier's Directory Service by dialing 411 or 1-555-1212. Wireless providers
19 have the option of providing this service by using their own facilities or by using a third-
20 party wholesale provider.

1 Internet Directory Providers

2 Internet sites are also comparable alternatives to traditional Directory Services and
3 continue to experience rapid growth as a result of increased Internet usage. These
4 services include Local and National Directory Assistance, category search, and search by
5 telephone number and are available to customers throughout the state of Missouri. Some
6 Internet sites also offer call completion and various information services. See Schedule 1
7 for the services offered by various Internet sites. There are literally hundreds of
8 companies providing directory listing information via the Internet. In fact, Internet
9 Directory Services are offered by all of the major Internet search engines and portals,
10 telecommunication providers, directory publishers, and a host of new Internet
11 companies.⁴ Companies offering Internet Directory Services include the following:

8 Additionally, the URL www.teldir.com/eng provides over 400 links to Internet
9 Directories. Attached as Schedule 5 are examples of the types of telephone listing
10 information available through Internet providers. In addition to simple Directory
11 Assistance, several Internet sites provide Call Completion options that compete with
12 SWBT, as well as other providers' Call Completion services. For example, AT&T's
13 ANYWHO.com offers a "Click to Call Now" feature that enables users to complete calls
14 to requested listings with software that AT&T provides for free at its web site. Similarly,
15 in March 1999, Qwest and Switchboard announced their plans to offer end users the
16 ability to "automatically place calls from the Internet," using "web-based click-to-
17 conference technology as well as other Internet-based telecommunication services." *See,*
18 *Schedule 5, pgs. 2, 3* for an example of this service.

19 Additionally, as the FCC has recognized, the historical distinctions between printed
20 directories and Directory Assistance have been blurred by the Internet. "For instance,
21 Internet users can now obtain access to databases that share many of the characteristics of
22 both paper directories and directory assistance [a]s with paper directories, users of

1 these databases can "look up" the telephone numbers of individual telephone exchange
2 service subscribers [and] ... obtain subscriber list information without consulting a paper
3 directory."⁵

4
5 With the dramatically increasing use of services providing high speed access to the
6 Internet including DSL, cable modems and satellite providers, as well as these services'
7 "always on" functionality, we will see an increasing use of these Internet directories
8 because of their power and convenience.

9
10 Directory Software, On-line Databases, Personal Digital Assistants

11 Residential and business end users can also purchase Directory software with a
12 comprehensive database of local and national listed telephone numbers. In Missouri, the
13 price of Directory software ranges from approximately \$19.99 to \$99.99. See Schedule
14 6 for a sample of Directory software offering. Additionally, with the storage of telephone
15 numbers in Palm Pilots and similar devices, these devices have become another substitute
16 product for traditional Directory Services, including Local Directory Assistance, and
17 National Directory Assistance.

18
19 White Pages and Yellow Pages Directory Publishers

1 The White and Yellow Page Directories offered throughout Missouri are also comparable
2 alternatives to SWBT's Local Directory Assistance for Missouri consumers and are made
3 available to consumers for no charge.

4
5 **Q. Are Directory Services also available from facilities-based and resale CLECs in**
6 **Missouri?**

7 A. Yes. As discussed above, Directory Service alternatives are available to an end-user
8 subscribing to SWBT's telecommunication services. Furthermore, if an end-user chooses
9 a facilities based or resale telecommunication provider for telecommunication services,
10 the end-user has Directory Service options available through these providers. Directory
11 Service alternatives are available from both facilities-based and resale telecommunication
12 providers. See Schedule 7 for samples of the tariffs filed by other Directory Service
13 providers.

14
15 CLECs provide Directory Services to their customers through their own facilities,
16 through a combination of their own facilities and SWBT's unbundled loops, or by
17 reselling SWBT's services.⁶ Similarly, wireless carriers provide Directory Services

4 SWBT also provides CLECs' end users access to its Directory Services on the same basis
5 as SWBT's retail end user customers as part of its resold local telecommunications
6 services. However, if the resale CLEC wishes to provide Directory Services itself or to
7 use a third-party Directory Service provider, the CLEC may choose to "custom route" its
8 end user Directory Service calls to itself or a third party provider it designates.⁷
9

10 **Q. Does SWBT face competition in Directory Services even when it provides local**
11 **service to the end user?**

12 A. Yes. Competitive alternatives exist for end users for Local Exchange Service and
13 Directory Service. If a customer switches to another provider for Local Exchange
14 Service, the end user may use the alternate provider for Directory Services. In addition,
15 if SWBT provides Local Exchange Service to the end users, those customers can also
16 choose to use other alternative providers for Directory Services.
17

18 **Q. Do these comparable alternatives provide the same functionality as SWBT's**
19 **Directory Services?**

Winstar obtains these services from Frontier ... [r]equesting carriers may also obtain OS/DA services and directory listings from numerous wholesale providers, including CenturyTel Telecommunications, Clifton Forge, Consolidated Communications, Excell, Experian's TEC Group, Frontier, HebCom, InfoNXX, MetroOne, Quest 411 and Teltrust."

1 A. Yes. The comparable alternatives discussed above offer the same, comparable and even
2 expanded functionality as addressed previously.⁸ In fact, several of the comparable
3 alternatives described above offer more functionality than SWBT's Directory Services.
4 For example, many wireless providers offer information services, such as directions,
5 stock quotes, weather and traffic reports, all via their Directory Service. Likewise,
6 AT&T's '00' Information service and Internet sites provide business category searches.

7
8 **Q. How do the rates for the comparable alternatives previously discussed compare to**
9 **SWBT's rates for Directory Services in Missouri?**

10 A. The rates available from the comparable alternatives are competitive with SWBT's rates
11 for Directory Services. See Schedule 8 for Directory Services rates for SWBT and a few
12 of the other competitive providers. In addition, many of the Directory Assistance Internet
13 Services are free to the end users. In fact, the Telephone Research and Action Center's
14 website (www.trac.org) provides a link to several free, on-line DA Internet Services.

15
16 **Q. Is it correct that several of these competitive alternatives are not regulated by the**
17 **Commission?**

18 A. Yes. Many of the alternatives I have described (e.g. Internet Directory Assistance
19 Services, Wireless Carriers' Directory Assistance and Directory Software) are not
20 regulated by the Commission. The alternatives that are under the jurisdiction of the

1 Commission (e.g., AT&T, MCIWorldCom and other interexchange carriers) are not
2 subject to the same DA regulation by the Commission.
3

4 **Q. Are these comparable alternatives available to end-users throughout Missouri?**

5 A. Yes. The alternatives outlined earlier are available in every SWBT exchange throughout
6 the state of Missouri.
7

8 **Q. Has the FCC ever issued a ruling relevant to the competitive nature of Directory
9 Services?**

10 A. Yes. The FCC has repeatedly found the Directory Services marketplace to be
11 competitive. In its UNE Remand Order,⁹ the FCC removed Directory Assistance services
12 from the list of unbundled network elements which Incumbent Local Exchange
13 companies ("ILECs") must provide to competitors because of the competitive nature of
14 the Directory Services market. As the FCC recognized, "competition in the provision of
15 ... directory assistance has existed since divestiture [s]uch competition has
16 accelerated in the directory assistance market as a result of the Supreme Court's decision
17 to allow copying of carriers' white page listings in their entirety."¹⁰ Similarly, in its
18 declaratory ruling on US West's provision of National Directory Assistance service, the
19 FCC found that there were a large and increasing number of players in the Directory

carriers.

1 ServicesDirectory Assistance Services market. In particular, when the FCC evaluated US
2 West's request for forbearance from federal 272 separation requirements for nonlocal
3 Directory Assistance, the FCC found that the company faced competition from numerous
4 sources, including CLECs, AT&T, MCIWorldCom.¹¹ In its Notice of Proposed
5 Rulemaking regarding the Provision of Directory Listing Information under the Act, the
6 FCC again stated that, "the provision of directory assistance has become increasingly
7 competitive."¹²

8
9 **Q. You mention that the Supreme Court has ruled that carriers' white pages listings**
10 **can be copied in their entirety. Does this mean that SWBT's white page listings are**
11 **able to be used for free by providers who want to provide their own Directory**
12 **Services?**

13 **A. Yes. Alternative providers of Directory Services are able to copy SWBT's listings for**
14 **free and can then provide whatever types of services they want using that information. In**
15 **addition to the obligation all LECs have under section 251(b)(3) of the Federal**
16 **Telecommunications Act of 1996 to provide their DA listings to requesting competing**

1 carriers and their agents, SWBT also makes its DA listings available to third-party DA
2 providers. Thus, competing carriers as well as non-carrier DA providers have access to
3 the same listing information that SWBT uses to provide DA services in Missouri.
4

5 **Q. Are Directory Services price deregulated in any states today?**

6 A. Yes, Directory Services are price deregulated in at least 15 states, including: Illinois,
7 Wisconsin, Kansas, Connecticut, Texas, Colorado, Idaho, Nebraska, North Dakota, South
8 Dakota, Washington, Wyoming, Maryland, Delaware, and New Jersey.
9

10 **Q. Do all of the services provided by SWBT within the Directory Services category**
11 **have alternative providers providing substitutable services at comparable rates,**
12 **terms and conditions?**

13 A. Yes. Every service provided by SWBT in the Directory Services family of services
14 covered in this testimony faces effective competition.
15

16 **Q. Do you believe that SWBT's Directory Services should be classified as competitive**
17 **as envisioned by Missouri statute?**

18 A. Yes. There are numerous telecommunications carriers and alternative providers in
19 Missouri providing substitutable products or services, considering both function and
20 price, to SWBT's Directory Services. Not only can consumers obtain listings by calling
21 several competing alternatives from their wireline phone, they can also obtain Directory

1 Services from print directories, by dialing 411 on their wireless phones, or they can
2 access, for free, various Directory Service websites over the Internet. The growth in the
3 number of competitors, the breadth of comparable alternatives, and the marketing efforts
4 of competitors support SWBT's position that comparable alternatives exist throughout all
5 of SWBT's exchanges in Missouri for Directory Services.

6
7 **Q. How will customers benefit from SWBT receiving a competitive classification for**
8 **Directory Services?**

9 A. Customers will be the benefactors of the change. SWBT will be able to respond more
10 quickly to the competitive marketplace, offering new products when appropriate at prices
11 in line with those offered by the competition. This will allow for unfettered competition
12 to drive product innovation.

13
14 **Q. Why should SWBT be granted a competitive classification for Directory Services?**

15 A. The fact that SWBT's prices are constrained by regulation limits SWBT's ability to
16 respond to changing customer demands and to changing competitive markets. All
17 competitors in today's competitive market should be treated on the same level field, thus
18 allowing for open competition to drive product innovation.

19
20 **Q. Please summarize your Directory Services testimony.**

21 A. Customers have numerous alternatives to Directory Services that are substitutable and
22 functionally equivalent in both function and price. Consumers can obtain listings by

1 calling several competing alternatives from their wireline phone, they can also obtain
2 Directory Services from print directories, by dialing 411 on their wireless phones, or they
3 can access various Directory Services websites over the Internet for free. In addition,
4 facilities-based and resale telecommunication providers also are providers of Directory
5 Services. Therefore, SWBT faces competition in Directory Services as CLECs gain
6 access lines and it faces competition in Directory Services even when it provides local
7 service to the end user.

8 Furthermore, the FCC has repeatedly found the Directory Services marketplace to be
9 competitive due to the large and increasing number of players in the Directory Services
10 market.

11 With the breadth of Directory Service alternatives available in the marketplace, it is
12 appropriate for the Commission to apply the same regulation to SWBT as it does to other
13 competitive telecommunications providers and therefore grant a competitive
14 classification for Directory Services.

15
16 **Operator Services**

17 **Q. What are the main points about your testimony that the Commission should**
18 **understand relative to Operator Services?**

19 **A. The Commission should understand the following points regarding Operator Services:**

- 20 ▪ The Commission found on December 21, 1992, in Case No. TO-93-116 that SWBT's
21 operator services were substitutable to those provided by interexchange carriers

1 (IXCs) and therefore deemed transitionally competitive. This is explained further in
2 the testimony of Mr. Hughes.

- 3 ▪ There are alternative providers providing substitutable services in all SWBT
4 exchanges in Missouri.
- 5 ▪ Operator Services meets the definition of effective competition, so the Commission
6 must acknowledge the competitive classification for Operator Services and confirm
7 that the price cap requirements no longer apply.
- 8 ▪ Some of the alternative providers providing substitutable services existed before
9 CLECs entered the market.
- 10 ▪ Competition for Operator Services is not simply a function of access line loss
11 incurred by CLEC entry.
- 12 ▪ SWBT's competitors do not have the same regulations that exist for SWBT so there is
13 an unlevel playing field in this market.
- 14 ▪ Customers derive the greatest benefit from a fully competitive market where all
15 competitors are free to fully compete.

16
17 **Q. Please describe the Operator Services offered by SWBT in Missouri.**

18 **A.** Operator Services refer to a variety of call completion services that SWBT offers its
19 customers in Missouri. These services facilitate the completion of a call, often using live
20 operators or through an automated Interactive Voice System (IVS). SWBT's Operator
21 Services in Missouri include calling cards, collect, billed to a third number, sent paid,
22 person-to-person service, line status verification, and busy line interrupt service. Callers

1 are billed a service charge (often referred to as a surcharge in the telecommunications
2 industry) in addition to a usage charge, where applicable, for these types of services.

3

4 **Q. Please identify the market segments and users of Operator Services.**

5 A. Users of Operator Services often are people in motion – anyone away from their own
6 home or business telephone and in need of an alternate method of making and billing
7 calls. The majority of callers requesting alternative billing originate calls from public
8 telephones at locations such as airports, hotels and shopping malls. A significant number
9 of Operator Services calls are also generated from college and university dorms,
10 hotel/motel guestrooms, and hospital patient rooms. A customer may use Operator
11 Services by dialing “0” or “0 plus a number” from any telephone, but generally use
12 Operator Services when placing a call when away from their home or office.

13

14 **Q. Please describe the competitive nature that exists in Missouri for Operator Services.**

15 A. Alternatives to SWBT’s Operator Services in Missouri are provided by numerous local
16 and toll telecommunication providers, including AT&T, Sprint and MCIWorldCom, as
17 well as wireless service providers, specialized Operator Service Providers, pay telephone
18 providers, prepaid and post-paid calling card providers and others.

19

20 **Q. Considering both function and price, please discuss the comparable alternatives to**
21 **SWBT’s Operator Services that are available in Missouri.**

22

1 A. Considering both function and price, end-users throughout Missouri have substitutable
2 and functionally equivalent alternatives for Operator Services offered by numerous
3 providers, including cellular telephone service, prepaid calling cards and personal 800
4 numbers. These services compete directly with SWBT's Operator Services in the state of
5 Missouri. The alternatives include:

6 '00' Service

7 This well-known service was established as a dialing pattern in order to route calls to the
8 operator of a customer's presubscribed interexchange carrier . '00' service may be used to
9 provide end-users throughout the state of Missouri with the complete range of calling
10 card, third number billing, collect and person-to-person calling options, as well as other
11 types of operator assistance, such as busy line verify and interrupt services and call
12 completion services. There are over 600 interexchange service providers certificated to
13 provide service in Missouri. See Schedule 4.

14 AT&T's 1-800-CALLATT Service

15 This service is available to all end-users throughout Missouri. Dialing 1800CALLATT
16 enables customers, regardless of their choice of local or toll provider, to obtain alternate
17 billing services, such as calling cards, collect, billed to a third number, person-to-person
18 service, line status verification, busy interrupt and AT&T customer service. AT&T
19 heavily promotes its Operator Services, as shown on Schedule 9.

20 MCIWorldCom's 1-800-COLLECT Service

21 This heavily promoted service is also available to all end-users throughout Missouri,
22 regardless of their choice of local or toll carrier. The service provides end-users the ability

1 to make collect calls from anywhere in the United States. Callers also have access to a
2 complete range of other services including calling cards, billed to a third number, person-
3 to-person service, line status verification, and busy interrupt. Samples of recent
4 promotional materials for these services are attached as Schedule 10.

5 1-800-2SPRINT

6 This service, similar to the services provided by SWBT, AT&T and MCIWorldCom,
7 offers end-users throughout Missouri the ability to make collect and calling card calls as
8 well as the typical range of live Operator Services, including billed to a third number,
9 person-to-person service, line status verification, and busy interrupt. Sprint also heavily
10 promotes its Operator Services. See Schedule 11.

11
12 Wireless Operator Services

13 Operator Services, including collect, billed to a third number, person-to-person service,
14 line status verification, and busy interrupt are also available from wireless carriers in
15 Missouri. Typically, wireless customers access their wireless carrier's Operator Services
16 by dialing 0 from their cell phone. Wireless providers have the option of providing this
17 service by using their own facilities or by using a third-party Operator Service Provider.

18 Moreover, wireless service itself has become a significant competitor to Operator
19 Services, particularly for services originating from pay telephones. Before wireless
20 services became ubiquitous, customers who were away from their home or business
21 telephone frequently used the alternative billing arrangements available through Operator
22 Services to place calls. However, today, many residence and business customers prefer

1 the convenience of placing calls through their wireless telephones to operator handled
2 telephone calls.

3 0+ and 0- Service from Pay Telephones

4 Pay telephone providers have the option of selecting the Operator Service Provider of
5 their choice for specific pay telephones (just as they have the option of selecting local
6 service and toll providers.) Since competition in the pay telephone industry has been
7 intense for years, this service has been deregulated. Customers can, in effect, choose an
8 Operator Service Provider through their choice of payphone provider. In many cases,
9 payphones also provide alternatives to operator handling by enabling customers to
10 "swipe" calling cards or credit cards for alternative billing.

11 12 Prepaid Calling Cards

13 Prepaid calling cards have also become an increasingly popular choice for alternative
14 billing arrangements historically provided by Operator Service Providers. As noted by
15 the Telecommunications Research and Action Center,

16 "The cards are being sold everywhere from the Internet to the convenience store.
17 The card is essentially a debit card which you buy for a specific amount of money
18 and is good for a specific amount of minutes. The major benefit of using a debit
19 card is the price. These cards do not have a surcharge like most other calling
20 cards. However, consumers should realize that the per-minute rates are usually
21 higher than other calling cards and calls you would make from home. Debit cards

1 are most economical for consumers who tend to make short calls away from
2 home."¹³

3
4 As with other types of calling cards, live or automated operator assistance is typically
5 available as required to assist in call completion. Prepaid cards are frequently branded in
6 the name of well-known retail establishments, now available virtually everywhere, from
7 the neighborhood gas station to Wal-Mart, K-Mart and 7-11 to the Internet.¹⁴ In addition,
8 prepaid calling cards are offered by all major telecommunication carriers including
9 AT&T, MCIWorldCom, Sprint and Qwest as well as hundreds of other lesser known
10 companies. See Schedule 12 for examples of Prepaid card providers.

11
12 10-10-XXX-00 Services

13 Regardless of the presubscribed carrier on any particular telephone line, end-users can
14 always reach the Operator Service Provider of their choice by dialing 10-10-XXX-00.
15 The "XXX" identifies the Carrier Identification Code ("CIC") and is routed to the
16 appropriate interexchange carrier. Currently, there are over 600 interexchange service
17 providers certificated to provide service in the state of Missouri.

18 "Personal" 800 Numbers

1 Many telecommunication carriers including MCIWorldCom, AT&T, and Sprint now
2 offer so-called "personal" 800 numbers. Once almost exclusively the province of
3 businesses which desired to offer toll free dialing to customers, residence customers may
4 now obtain 800 service as an alternative to collect calling. These services are
5 increasingly popular among parents with children at college and residence customers who
6 travel extensively and desire a convenient way to call home.

7
8 **Q. Does SWBT face competition in Operator Services even when it provides local**
9 **service to the end user?**

10 A. Yes. Competitive alternatives exist for end users for Local Exchange Service and
11 Operator Service since Operator Services is available from facilities-based and resale
12 telecommunication providers. If a customer switches to another provider for Local
13 Exchange Service, the end user may use the provider for Operator Service. In addition, if
14 SWBT provides Local Exchange Service to the end users, those customers can also
15 choose to use other alternative providers (mentioned above) for Operator Service.

16
17 **Q. Are Operator Services available from facilities-based and resale telecommunication**
18 **providers in Missouri?**

19 A. Operator Services are available from facilities-based and resale telecommunication
20 providers, as well as cellular telephone providers. The market is open to competition as
21 recognized by the Commission in its order in Southwestern Bell's 271 proceeding.¹⁵

Net2Phone.

1 Moreover, Operator Services are provided by facilities-based (e.g., AT&T,
2 MCIWorldCom and Sprint) interexchange carriers, resale and switch-based CLECs and
3 specialized Operator Service Providers that utilize their own facilities to provide services
4 directly to end-users or to other providers, pay telephone providers and places of public
5 accommodation. Companies that provide Operator Services to end-users have many
6 different alternative sources for provisioning these services. Interexchange carriers,
7 CLECs, wireless carriers, independent local exchange carriers, pay telephone companies
8 and others can also choose to provide Operator Services through their own employees
9 and facilities or can utilize the services of a third-party Operator Service Provider.
10 Attached as Schedule 13 are samples of Operator Service tariffs filed by other providers.
11

12 **Q. Do these comparable alternatives provide the same functionality as SWBT's**
13 **Operator Services?**

14 A. Yes, as previously discussed, these alternatives offer substitutable or functionally
15 equivalent service.
16

17 **Q. How do the comparable alternatives Operator Service rates compare to SWBT's**
18 **rates for Operator Services in Missouri?**

19 A. Rates for the comparable alternatives described above are comparable to SWBT's rates
20 for Operator Services. See Schedule 14 for a comparison of Southwestern Bell's Operator
21 Service rates to a few of the comparable alternatives.
22

23 **Q. Are these comparable alternatives available to end-users throughout Missouri?**

1 A. Yes. The alternatives outlined earlier are available in all SWBT exchanges throughout
2 the state of Missouri.

3
4 **Q. Has the FCC ever issued a ruling relevant to the competitive nature of Operator**
5 **Services?**

6 A. Yes. The FCC has found the Operator Services marketplace to be competitive. Similar
7 to Directory Assistance, in its UNE Remand Order, the FCC removed Operator Services
8 from the list of unbundled network elements because of the competitive nature of the
9 market. In fact, the FCC specifically stated that “[incumbent local exchange carriers]
10 need not provide access to its Operator Services and Directory Assistance as an
11 unbundled network element.”¹⁶

12

13 **Q. Are Operator Services price deregulated in any states today?**

14 A. Yes, Operator Services are price deregulated in the following states:
15 Arkansas, California, Indiana, Michigan, Texas, Kansas, and Wisconsin.

16

17 **Q. Have SWBT’s Operator Services previously received a competitive classification in**
18 **Missouri?**

19 A. Yes. As more fully explain in the testimony of Mr. Hughes, SWBT’s “Station to
20 Station”, “Person to Person” and “Calling Card” Operator Services were found to be
21 transitionally competitive in 1992 In Case No. TO-93-116. Subsequent to that finding,
22 and following an extension of the transitionally competitive classification, pursuant to

1 392.370.2 these services automatically became classified as competitive on January 10,
2 1999.

3
4 **Q. Do all of the services provided by SWBT within the Operator Services category**
5 **have alternative providers providing substitutable services at comparable rates,**
6 **terms and conditions?**

7 A. Yes. Every service provided by SWBT in the Operator Services family of services
8 covered in this testimony faces effective competition throughout the state of Missouri.

9
10 **Q. Are any of these alternative services price regulated like SWBT is?**

11 A. No, the price cap regulation imposed on SWBT for operator services is not imposed on
12 the competitors.

13
14 **Q. Do you believe that the Commission should confirm that all of SWBT's Operator**
15 **Services face effective competition and therefore, the price cap constraints no longer**
16 **apply?**

17 A. Yes. There are numerous telecommunications carriers and alternative providers in
18 Missouri providing substitutable products or services, considering both function and
19 price, to SWBT's Operator Services. Consumers have numerous options including local
20 and toll telecommunication providers as well as wireless service providers, pay telephone

1 providers and prepaid calling card providers. The growth in the number of competitors,
2 the breadth of comparable alternatives, and the marketing efforts of competitors support
3 SWBT's position that comparable alternatives exist throughout all of SWBT's exchanges
4 in Missouri for Operator Services.

5
6 **Q. How will customers benefit from a fully competitive Operator Services market?**

7 A. Customers will be the beneficiaries of the change. SWBT will be able to respond more
8 quickly to the competitive marketplace, offering new products when appropriate at prices
9 in line with those offered by the competition. This will allow for unfettered competition
10 to drive product innovation.

11
12 **Q. Why should the Commission acknowledge the competitive classification on SWBT's**
13 **Operator Services and confirm that the price cap regulations no longer apply?**

14 A. The fact that SWBT's prices are constrained by regulation limits SWBT's ability to
15 respond to changing customer demands and to changing competitive markets. SWBT's
16 competitors are not regulated in the same fashion. All competitors in today's competitive
17 marketplace should be treated on the same level field, thus allowing for open competition
18 to bring about the full benefits of a competitive market.

19
20 **Q. Please summarize your Operator Services testimony.**

21 A. Customers have numerous alternatives to Operator Services. The alternatives include
22 local and toll telecommunication providers, wireless service providers, specialized

1 Operator Service Providers, pay telephone providers and calling card providers. In
2 addition, facilities-based and resale telecommunication providers also are providers of
3 Operator Services. Therefore, SWBT faces competition in Operator Services as CLECs
4 gain access lines and it faces competition in Operator Services even when it provides
5 local service to the end user. Furthermore, considering both function and price, end-users
6 throughout the State of Missouri have substitutable and functionally equivalent
7 alternatives for Operator Services.

8 With the breadth of Operator Service alternatives available in the marketplace, it is
9 appropriate for the Commission to apply the same regulation to SWBT as it does to other
10 competitive telecommunications providers. And, therefore, acknowledge the competitive
11 classification on SWBT's Operator Services and confirm that the now outdated price cap
12 regulations no longer apply.

13

14 Q. Does this conclude your testimony?

15 A. Yes

- A new expanded search capability allows AT&T information assistants to extend a directory search to surrounding communities when they can't find a requested listing in a designated city or town -- even if the caller doesn't know what those communities are.
