ORDER AMENDING PROCEDURAL SCHEDULE

USCOC of Greater Missouri, LLC d/b/a U.S. Cellular has applied to the Commission for designation as an Eligible Telecommunications Carrier pursuant to the Telecommunications Act of 1996. On October 17, 2006, the Commission adopted a procedural schedule leading to a hearing on November 20 and 21. Those hearing dates were chosen by the Commission as a compromise between the October 25-27 hearing dates proposed by U.S. Cellular and the December 18-20 hearing dates proposed by the other parties.

On October 24, U.S. Cellular filed a motion indicating that its expert witness would not be available on the chosen hearing dates. As a result, U.S. Cellular requests that the Commission adopt the procedural schedule proposed by the other parties. The motion represents that the other parties do not oppose this proposed revision to the procedural schedule.

Given the agreement of the parties, the Commission will grant U.S. Cellular's motion.
