## ORDER APPROVING COMPLIANCE TARIFF

Issue Date: July 5, 2022

Effective Date: July 16, 2022

On March 24, 2021, the Commission approved a unanimous stipulation and agreement and granted Union Electric Company d/b/a Ameren Missouri a certificate of convenience and necessity for a solar generating facility in Montgomery County, Missouri. That facility serves as the second Program Resource for Ameren Missouri's Community Solar Pilot Program. On May 16, 2022, Ameren Missouri filed a revised tariff to update program charges related to the completion of the Montgomery County Community Solar Energy Center. To give the Staff of the Commission sufficient time to review the in-service criteria and information, the tariff effective date was suspended until July 16, 2022. On June 30, 2022, Staff recommended that the revised tariff sheet be approved.

The revised tariff sheet will decrease the Solar Generation charge from \$10.78 to \$8.51 and the Total Solar Block Charge for Small General Service from \$13.26 to \$10.99. Staff found the Montgomery County Community Solar Energy Center fully operational and used for service as of March 22, 2022. Staff recommended the revised tariff sheet become effective on July 16, 2022.

The Commission directed any response to Staff's recommendation be filed no later than June 30, 2022. Ameren Missouri responded on June 30, indicating its agreement with Staff's recommendation.

After reviewing the revised tariff sheet and Staff's recommendation, the Commission finds Ameren Missouri's revised tariff sheet complies with the Commission's order. The Commission will approve the tariff. Because the tariff effective date is July 16, 2022, and to make the reduced charges effective expeditiously, the Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheet filed on May 16, 2022, by Union Electric Company d/b/a Ameren Missouri, Tracking No. YE-2022-0259, is approved to become effective on July 16, 2022.
2. This order shall be effective on July 16, 2022.
