On December 21, 2021, the Commission directed its Staff (Staff) to file a pleading stating the date it would be able to file a recommendation about Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West's (collectively "Evergy") application for a Certificate of Convenience and Necessity (CCN) to construct and operate a new solar production facility. Staff responded that it can file a recommendation by March 10, 2022. The Commission will direct Staff to file a recommendation by that date and set a time for responses.

- 1. Staff shall file a recommendation regarding Evergy's CCN application no later than March 10, 2022.
