**ORDER GRANTING AN EXTENSION OF TIME TO  
RESPOND TO STAFF’S RECOMMENDATION**

On January 11, 2022, the Commission directed its Staff (Staff) to file a recommendation concerning Evergy Missouri Metro and Evergy Missouri West’s (Evergy) application to construct a solar facility. The Commission set a deadline of March 21, for any responses to Staff’s recommendation or Evergy’s application. That deadline was then extended to April 7, April 21, and April 28.

On April 28, Evergy filed an additional request for an extension of time to respond to Staff’s recommendation. In support of its motion Evergy states that it is still engaged in discussions concerning a settlement. Evergy represents that all the parties have been informed about its extension request, and none have objected. The Commission will grant Evergy’s motion and extend the response deadline for all parties.

**THE COMMISSION ORDERS THAT:**

1. Evergy’s motion is granted. **All** parties have until May 5, 2022, to file a settlement agreement or response to Staff’s recommendation.

2. This order is effective when issued.
