## ORDER DIRECTING FILING

On July 14, 2022, the Commission issued an order giving notice and setting deadlines in the application for a certificate of convenience and necessity filed by Union Electric Company d/b/a Ameren Missouri. In that order the Commission noted that Ameren Missouri had failed to include “[a] list of all electric, gas, and telephone conduit, wires, cables, and lines of regulated and nonregulated utilities, railroad tracks, and each underground facility, as defined in section 319.015, RSMo, which the proposed construction will cross” as required by 20 CSR 4240-20.045(6)(B). The Commission stated that it would direct Ameren Missouri to file the list of utilities, etc. but no order was included setting a time for Ameren Missouri to do so. Therefore, the Commission will direct Ameren Missouri to make this filing to correct the deficiency.

### THE COMMISSION ORDERS THAT:

1. No later than July 25, 2022, Ameren Missouri shall file the list of utilities, etc. as required by Commission Rule 20 CSR 4240-20.045(6)(B). Such list shall include the general mailing address and email address, if available, where the Commission may send notice of the application.

2. This order shall be effective when issued.
