1 P R O C E E D I N G S

2 JUDGE WOODRUFF: We're back on the record
3 in Case Nos. HR-99-245, GR-99-246 and ER-99-247,
4 which is consolidated with EC-98-573. While we
5 were off the record, I was informed that there has
6 been an agreement reached in this case.

7 Mr. Swearengen, I believe you're going to
8 make a motion?

9 MR. SWEARENGEN: Yes, your Honor. The
10 parties have reached an agreement in principle to
11 settle all three rates cases, the electric case,
12 the steam case, as well as the gas case. We intend
13 to reduce those agreements to writing and file
14 unanimous stipulations in each of the dockets by
15 Wednesday of next week. Thank you.

16 JUDGE WOODRUFF: Very good.

17 Any other party want to be heard on that
18 motion?

19 MR. CONRAD: Your Honor, we would join on
20 behalf of industrials on that motion.

21 JUDGE WOODRUFF: Okay. Public Counsel?

22 MR. COFFMAN: Yes.

23 JUDGE WOODRUFF: Staff?

24 MR. HAAS: Staff agrees and has nothing to
25 add.

1 MR. SWEARENGEN: I probably ought to say
2 that pending that I would ask that the hearings be
3 continued indefinitely in all three dockets.

4 JUDGE WOODRUFF: Yes. The motion will be
5 granted. The hearings today are continued
6 indefinitely. The parties shall submit the
7 stipulation and agreement in writing by July 14th,
8 and the Commission will go ahead and establish a
9 date for a hearing on the stipulation and agreement
10 for August the 9th beginning at 8:30 a.m. In the
11 event that the Commission does not have any
12 questions concerning the stipulation, I'll send out
13 a notice indicating that the August 9th hearing
14 will be cancelled.

15 MR. SWEARENGEN: The only thing I would
16 add, your Honor, is you're saying stipulation
17 singular. We're going to file a stipulation in
18 each of the three dockets, and I take it we would
19 hear them all at the same time.

20 JUDGE WOODRUFF: Yes, we would, and I
21 thank you for that clarification.

22 Any other matters? Mr. Conrad?

23 MR. CONRAD: Your Honor, I don't know if
24 it's premature in the way we're handling it, but
25 let me raise it for your discretion. The parties

1 have pursuant to our discussions yesterday,
2 prepared and circulated among themselves an exhibit
3 with numbered -- assigned numbers to their
4 respective exhibits and prepared lists of those
5 numbers and the witnesses and the identification of
6 exhibit. If you wish, I think all of us have those
7 exhibits here. We actually carried them up back
8 and forth yesterday, but having no desire to
9 inflict that upon our much beloved court reporter,
10 but it would perhaps be appropriate to deal with
11 those either off the record or on as you see fit.

12 JUDGE WOODRUFF: Let's go off the record
13 for a moment.

14 (OFF THE RECORD.)

15 JUDGE WOODRUFF: We've had some
16 discussions about the exhibit list, and it's
17 decided that we will go ahead and accept them for
18 marking. So we'll go off the record, and we'll go
19 ahead and mark the exhibits.
