On behalf of Missouri-American Water Company ("MAWC" or "Company"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing certain tariff rate sheets in electronic form consisting of revised water and sewer tariff sheets. The proposed tariff rate sheets are listed on <u>Appendix A</u>, bear a date of issue of August 19, 2011, and an effective date of September 19, 2011.

The purpose of this filing is to implement a general rate increase for water and sewer service provided by MAWC in the Roark Water District and Roark Sewer District . The revised rates are designed to produce an additional \$54,462 in gross annual water revenues (excluding gross receipts and sales taxes) or a 21.04% increase over existing water revenues and an additional \$116,565 in gross annual sewer revenues (excluding gross receipts and sales taxes) or a 39.04% increase over existing sewer revenues.

Further provided in electronic form is the direct testimony and schedules of Dennis R. Williams. MAWC's Minimum Filing Requirements, as required by Commission Rule 4 CSR 240-3.030(3)(B), are contained in Schedule DRW-1, attached to the Direct Testimony of Dennis R. Williams.
