In accordance with 4 CSR 240-20.090(4), The Empire District Electric Company (“Empire” or “the Company”) hereby submits to the Missouri Public Service Commission (“Commission”) information regarding true-up adjustments that are necessary due to an over-collection of eligible fuel and purchased power costs during the Recovery Period ending November 30, 2015. As explained in the direct testimony of Todd W. Tarter, Empire’s Manager of Strategic Planning, which accompanies this filing, Empire’s over-collection for the Recovery Period totaled approximately \$225 thousand.

Copies of this true-up filing will be served electronically, this date, on the Commission’s General Counsel, the Office of the Public Counsel, and on each party to the Company’s last general rate case.


