ORDER SUSPENDING TARIFF AND SETTING PREHEARING CONFERENCE

Issue Date: June 16, 2005 Effective Date: June 22, 2005

On May 27, 2005, AT&T Communications of the Southwest, Inc. filed tariff sheets to revise the prorating language that applies when customers disconnect their service prior to the end of their billing cycle. The tariff sheets have an effective date of June 26, 2005.

Under Section 392.230.3, RSMo 2000, the Commission may suspend the proposed tariff revisions for a period of 120 days and, if unable to complete a hearing within that time period, for another six months. In order to determine whether the proposed tariff revisions are lawful and reasonable, the Commission will suspend the tariff.

To ensure its prompt resolution, the Commission will also set this matter for prehearing conference. At the prehearing conference, the parties or their representatives should be prepared to discuss the nature of any discovery each will conduct and the interval necessary for its completion; the number of witnesses each expects to call at hearing; the number and nature of any exhibits each expects to offer at hearing; and the anticipated length of the hearing.

The parties shall jointly file a proposed procedural schedule. The proposed procedural schedule shall establish dates for the filing of a list of the issues to be determined by the Commission and statements by the parties of their position on each issue. The proposed procedural schedule shall also include a date for the filing of a list of the witnesses to be called on each day of hearing, the order in which they shall appear, and the order of cross-examination agreed upon by the parties. The proposed procedural schedule shall also suggest dates for the hearing of this matter.

IT IS THEREFORE ORDERED

- That the revised tariff sheets, Tariff File No. JC-2005-1063, filed by AT&T
 Communications of the Southwest, Inc. are suspended for a period of 60 days, until
 August 25, 2005.
- 2. That a prehearing conference shall be held on June 22, 2005, beginning at 10:00 a.m. The prehearing conference shall be held in Room 305 at the Commission's office in the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, a building that meets accessibility standards of the Americans with Disabilities Act.
