On March 24, 2023, the Staff of the Commission (Staff) filed a *Motion to Cancel Registration* regarding the service authority to provide interconnected voice over internet protocol (IVoIP) services and to provide basic local exchange and non-switched local exchange telecommunications service of RTC Solutions, Inc..
