**NOTICE OF ADOPTION OF INTERCONNECTION,
RESALE AND UNBUNDLING AGREEMENT**

COMES NOW CenturyTel of Missouri, LLC ("CenturyTel") and respectfully files this Notice of Adoption of Interconnection, Resale and Unbundling Agreement ("Notice of Adoption") pursuant to Section 252(i) of the Telecommunications Act of 1996 and 4 CSR 240-2.080 (3).¹ In connection with this filing, CenturyTel states as follows:

1. CenturyTel is a Louisiana limited liability corporation that is duly authorized to do business in the state of Missouri. Copies of CenturyTel's Certificate of Authority to transact business in Missouri from the Missouri Secretary of State were filed in Case No. TM-2002-232, and are incorporated herein by reference. CenturyTel's principle place of business is 100 CenturyTel Drive, Monroe, Louisiana 71203. The designated contact for purposes of the above-captioned, adopted Agreement is:

2. Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the "Federal Act"), Tele-Reconnect, Inc. ("Tele-Reconnect") notified CenturyTel that it desired to adopt the terms of the Interconnection, Resale and Unbundling Agreement ("Terms") between CenturyTel and Missouri Telecom, Inc. ("MTI") approved by the Missouri Public Service Commission ("Commission") in Case Number TK-2003-0357 ("Underlying Agreement"). Subsequent to this, CenturyTel and Tele-Reconnect signed a cover letter relating to Tele-Reconnect's adoption of the Terms. A copy of said cover letter is attached to the Underlying Agreement, and that complete document is numbered seriatim and attached hereto as Attachment 1.

3. Section 252(i) of the Federal Act provides as follows:

(i) AVAILABILITY TO OTHER TELECOMMUNICATIONS CARRIERS.-

A local exchange carrier shall make available any interconnection services, or network element provided under an agreement approved under this section to which it is a party to any other requesting telecommunications carrier upon the same terms and condition as those provided in the agreement.

4. A copy of the Commission's April 28, 2003 Order approving the Underlying Agreement is attached hereto as Attachment 2. As described in the Order, the Commission approved the Underlying Agreement pursuant to Section 252(e) of the Federal

Act by finding that it was consistent with the public interest, convenience and necessity and did not discriminate against any telecommunications carrier. Accordingly, the Terms are adopted by Tele-Reconnect and will apply to Tele-Reconnect and CenturyTel pursuant to Section 252(i) of the Act. There are no outstanding issues between CenturyTel and Tele-Reconnect relating to such adoption.

WHEREFORE, CenturyTel respectfully submits this Notice of Adoption of Interconnection, Resale and Unbundling Agreement and requests that the Commission take notice of such adoption pursuant to its authority to regulate telecommunications carriers in the state of Missouri.




