**MOTION TO CANCEL IVoIP REGISTRATION**

COME NOW Telrite Corporation ("Telrite") and Applewood Communications Corporation ("Applewood") (together "Movants"), by and through counsel, and hereby jointly request the Commission to cancel the Interconnected Voice over Internet Protocol registration of Applewood Communications Corporation in Missouri. In support of this motion, Movants state as follows:

1. Applewood Communications Corporation obtained an Interconnected Voice Over Internet Protocol (IVoIP) Registration from this Commission on August 3, 2009. MoPSC File No. DA-2010-0016.
2. On January 23, 2013, the Commission issued its *Order Acknowledging Transfer of Customers, Cancellation of Certificate and Tariff, and Approval of Tariff Revisions* in MoPSC File No. XM-2013-0308. That *Order* became effective February 3, 2013.
3. In its *Order* of January 23, 2013, the Commission acknowledged the transfer of assets from Applewood to Telrite as set out in Movants' *Joint Application* in XM-2013-0308, cancelled Applewood's Missouri

certificate of service authority and cancelled Applewood's Missouri tariff, all effective February 3, 2013.

4. Movants inadvertently omitted any reference to Applewood's Missouri VoIP registration in their *Joint Application* in File No. XM-2013-0308. That VoIP registration is no longer needed. As a result, Movants request that said VoIP registration be cancelled by the Commission.
5. Both Telrite and Applewood are current in all required filings to the Commission.

WHEREFORE, Telrite Corporation and Applewood Communications Corporation respectfully request that the Missouri Public Service Commission cancel the Interconnected Voice over Internet Protocol Registration issued to Applewood Communications Corporation in File No. DA-2010-0016.
