On August 28, 2008, House Bill 1779 became effective, modifying

Section 392.420, RSMo 2000, so that it now provides, in pertinent part:

[F]or all existing alternative local exchange telecommunications companies, the commission shall waive, at a minimum, the application and enforcement of its quality of service and billing standards rules, as well as the provisions of subsection 2 of section 392.210, subsection 1 of section 392.240, and sections 392.270, 392.280, 392.290, 392.300, 392.310, 392.320, 392.330, and 392.340.

On January 18, 2010, Budget PrePay, Inc., filed an application with the Missouri

Public Service Commission for waiver of certain Commission rules and statutory provisions

pursuant to Section 392.420, RSMo.

On January 28, 2010, the Commission Staff submitted its recommendation. Staff

noted that:

1. Budget PrePay is an alternative local exchange telecommunications

company as that term is used in Section 392.420.

2. Budget PrePay is currently compliant in obligations relating to Commission

assessment, Missouri Universal Service Fund, Relay Missouri, and the submission of annual reports.

The waivers requested by Budget PrePay are:

- 392.210.2 Accounting requirements (system of accounts)
- 392.240.1 Reasonableness of rates
- 392.270 Accounting requirements (valuation of property)
- 392.280 Accounting requirements (depreciation rates/accounts)
- 392.290 Issuance of stocks, bonds and other indebtedness
- 392.300 Transfer of property and ownership of stock
- 392.310 Approval of issuing stocks, bonds and other indebtedness
- 392.320 Certificate of Commission to be recorded-stock dividends
- 392.330 Accounting requirements (proceeds of sales of stock, bonds, notes, etc.)
- 392.340 Company reorganization
- 4 CSR 240-3.550(4), (5)(A), and 5(C) Held order records, quality of service reports.
- 4 CSR 240 240-10.020 Income on depreciation fund investments
- 4 CSR 240-30.040 Uniform System of Accounts
- 4 CSR 240-32.060 Engineering and maintenance
- 4 CSR 240-32.070 Quality of Service
- 4 CSR 240-32.080 Service objectives and surveillance levels

Staff recommends that the Commission grant Budget PrePay the waivers it

requests.

In addition to the waivers required to be granted by Section 392.420, Budget

PrePay has requested a waiver of 4 CSR 240-32.050(4)(B) to the extent previously

provided to other carriers in File No. IE-2009-0357. The Commission finds that good cause

exists to grant a partial waiver of the rule to the same extent granted to other carriers in File

No. IE-2009-0357

THE COMMISSION ORDERS THAT:

1. Budget PrePay, Inc.'s Application for Waiver of Certain Commission Rules and Statutes is granted.

2. Budget PrePay is directed to list the waivers granted in its tariffs no later than February 22, 2010.

3. This order shall become effective upon issuance, after which this case may

be closed.
